

ORDINANCE No. 185711

*Authorize a grant agreement with Linnton Community Center for operational costs associated with after school programs for youth. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. There are no City of Portland parks or recreational facilities located in Linnton.
2. The Linnton Community Center has experienced financial difficulties due to the increasing needs of the Linnton community and the lack of sustained funding.
3. There is a need for on-going funding from the City to support the Linnton Community Center's after school recreational and enrichment programs for youth.
4. The Linnton Community Center is in need of support to their facilities and programs. The purpose of this grant is to support the Linnton Community Center's general operations, explicitly for out-of-school-hours youth services.
5. The Linnton Community Center will report to Portland Parks & Recreation how they use the grant funds, along with how many youth are served by the programs supported by this grant.

NOW, THEREFORE, The Council Directs:

- a. The Director of the Bureau of Parks & Recreation is authorized to enter into a grant agreement with the Linnton Community Center. The agreement will be substantially similar to the attached and will be approved as to form by the City Attorney.
- b. Portland Parks & Recreation is authorized to make grant payments to Linnton Community Center in accordance with the terms and conditions stated in the grant agreement.

Section 2. The Council declares that an emergency exists in order to avoid further delay in the provision of funding for the ongoing operations of the Linnton Community Center; therefore, this Ordinance shall be in force and effect from and after its passage by Council.
