

ORDINANCE No. 185739

*Accept a grant in the amount of \$465,535 from the Portland Development Commission for the West Burnside and Pearl District Intersection Safety and Access Project (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. On June 13, 2012, the Pearl District Access and Circulation Plan was adopted by City Council, Resolution No. 36932, in response to the need for improved access and safety improvements in and through the district.
2. Council directed the Bureau to collaborate with stakeholders to implement the projects, and as the first implementing action, to install traffic signals at seven key priority intersections. The Transportation Commissioner further clarified that these signalization improvements were to include left-turn lanes on West Burnside Street in order to further the access and economic development objectives of the plan.
3. Portland Transportation and the Portland Development Commission staff developed an implementation plan, the funding of which includes a grant from the River District Urban Renewal Area and Transportation System Development Charge funds.
4. On September 10, 2012, an Intergovernmental Agreement was executed between the Director of the Portland Development Commission and the Director of the Portland Bureau of Transportation.
5. These grant funds (grant no. TR000202) should now be accepted and the FY 12-13 budget for Portland Transportation should be amended to include this project.

NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from the Portland Development Commission for the West Burnside and Pearl District Intersection Safety and Access Project in the amount of \$465,535.
- b. The FY 2012 / 2013 budget is hereby amended as follows:

- c. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.


