## ORDINANCE No. 185742

Authorize contract and provide for payment for construction of the SW Sunset Blvd Sidewalk Infill Project (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Bureau of Transportation has identified critical gaps in the sidewalk network on arterial streets in Southwest Portland.
- 2. Bureau staff worked with Southwest Neighborhoods, Inc. to identify and select priority sidewalk projects to build with \$8 million for sidewalks on arterial streets in Southwest Portland.
- 3. SW Sunset Boulevard from SW Dewitt Street to SW 18th Drive was identified as a priority sidewalk infill project.
- 4. The Bureau of Transportation hired HHPR to prepare plans, specifications and an estimate for the project construction.
- 5. The Bureau of Transportation has funds budgeted in FY 12/13 to construct, inspect and manage the project.
- 6. The Bureau's level of confidence in the cost estimates for this project is moderate. The project is defined and plans and specifications are 90% complete.

NOW, THEREFORE, the Council directs:

- a. Upon the Council's acceptance of the Chief Procurement Officer's report recommending the lowest responsible bidder, the Chief Procurement Officer is authorized to execute a contract, provided the contract has been approved as to form by the City Attorney's office.
- b. The Auditor is authorized to draw and deliver warrants chargeable to T00281.C42 when demand is presented and approved by the proper authority.
