## ORDINANCE No. 185797

\* Increase contract with James W. Fowler Co. for additional construction services provided on the Phase 1 riverbank restoration of the South Waterfront Greenway Central District project (Ordinance; amend Contract No. 30002713)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Council provided support and direction for the development of the South Waterfront Greenway Central District Improvements through Resolution No. 36273 in December 2004, Ordinance 184389 in January 2011 and acceptance of the Guaranteed Maximum Price proposed by JW Fowler Co. of \$4,035,843.62 for the Phase 1 improvements in May 2012.
- 2. In August 2011 Council in Ordinance 185370 accepted a grant in the amount of \$1,300,000 and authorized an Intergovernmental Agreement with TriMet for Wetland Mitigation within the Greenway Central District project.
- 3. The shallow water habitat portion of the Phase 1 improvements could not be completed on schedule because river levels remained unusually high, so Phase 1 has been split into Phase 1A, to be completed in spring of 2013 and Phase 1B, to be completed in the fall of 2013.
- 4. JW Fowler Co. has provided or will provide extra construction services in Phase 1A related to adjusting the construction plan to unusually high river levels; excessive volumes of contaminated soil and debris; design adjustments related to soft soils; and expenses associated with the increased duration of the construction.
- 5. Change Orders 1 through 7 have been administratively executed and increased the contract amount to \$4,907,403.06, representing a 21.60% increase.
- 6. A further increase to the contract amount of \$401,356.23 will be required to complete Phase 1A. The new value of Contract No. 30002713 will be \$5,308,759.29. Funds for this increase will come from the existing project budget.

#### NOW, THEREFORE, The Council Directs:

- a. The Chief Procurement Officer is hereby authorized to execute Change Orders to increase the contract amount of Contract No. 30002713 up to a not to exceed total contract value of \$5,308,759.29.
- b. The Commissioner and Auditor are authorized to provide payment chargeable to the applicable budgets under project code P00193 when demand is presented and approved by the appropriate authorities.
