Changes are mandatory because ORS 455.040 requires that the State Building Codes be uniform throughout the State. Four new titles were added to the Oregon Building Code, including the Oregon Energy Efficiency Specialty Code, which took effect on July 1, 2010, the Oregon Solar Installation Specialty Code, which took effect on October 1, 2010, the 2010 Edition of the Oregon Manufactured			
Dwelling Installation Specialty Code, which took effect on April 1, 2010, and the 2002 Edition of the Oregon Manufactured Dwelling and Park Specialty Code, which took effect on April 1, 2002. The City administers these provisions, so it must adopt them formally into the City Code.			
Additionally, because the City adopted Chapter 24.90 of the City Code, entitled, "Manufactured Dwelling Installation and Accessory Structures, Manufactured Dwelling Parks, Recreational Parks, Park Trailer Installations and Accessory Structures," before the State adopted the 2002 Oregon Manufactured Dwelling and Park Specialty Code and the 2010 Oregon Manufactured Dwelling Installation Specialty Code, Chapter 24.90 needs to be revised to conform to these State specialty codes and the corresponding Oregon Administrative Rules (OAR) and to correct other minor errors and internal inconsistencies. for Five Story Apartment Buildings)

Requested Council Hearing Date: <u>December 12, 2012</u>

RECOMMENDATION I.

Amend Titles 24 and 27 to adopt new State specialty codes, including the 2010 Energy Efficiency Specialty Code, the 2010 Solar Installation Specialty Code, the 2010 Manufactured Dwelling Installation Specialty Code, and portions of the 2002 Oregon Manufactured Dwelling and Park Specialty Code pertaining to manufactured dwelling parks; amend Chapter 24.90; repeal Chapter 24.95.

BACKGROUND II.

In addition to the State specialty codes that the City has regularly adopted, the State recently adopted four new specialty codes. These additional codes include:

- Energy Efficiency Code (ORS 455.496). This code was previously Chapter 13 of the Structural Specialty Code, but it was made a separate stand-alone code, effective April 1, 2010.
- Solar Installation Specialty Code (ORS 455.020(2) and 455.496; OAR 918-800-0020). The Solar Installation Specialty Code is a new code regulating installation of solar systems that the State adopted, which took effect on October 1, 2010.
- Manufactured Dwelling Installation Specialty Code, 2010 Edition (ORS 446.062, 446.185) and the 2002 Manufactured Dwelling and Park Specialty Code (ORS 446.062; OAR 918-600-0010). The State first adopted the Oregon Manufactured Dwelling and Park Specialty Code in 2002 (the 2002 Code). City Code Chapter 24.90 contains City regulations concerning manufactured dwelling installation and parks, which the City adopted prior to the State adoption of the 2002 Code. The City never formally adopted

the 2002 Code, although the City has been administering it since 2002. The State most recently adopted a new specialty code entitled, Oregon Manufactured Dwelling Installation Specialty Code, 2010 Edition, which replaced all of the 2002 Code, except for the provisions in the 2002 Code regulating manufactured dwelling parks. The 2010 Manufactured Dwelling Installation Specialty Code took effect on April 1, 2010. (OAR 918-500-0510.)

The City administers these State codes and, therefore, should formally adopt them as it has with the other specialty codes it administers.

Because the City added Chapter 24.90 to the City Code, entitled, "Manufactured Dwelling Installation and Accessory Structures, Manufactured Dwelling Parks, Recreational Parks, Park Trailer Installations and Accessory Structures," before the State adopted the 2002 Oregon Manufactured Dwelling and Park Specialty Code and the 2010 Oregon Manufactured Dwelling Installation Specialty Code, Chapter 24.90 needs to be revised to conform to these State specialty codes and the corresponding Oregon Administrative Rules (OAR) and to correct other minor errors and internal inconsistencies.

Chapter 24.95 of the City Code, entitled, "Special Design Standards for Five Story Apartment Buildings," is obsolete because the current International Building Code and Oregon Structural Specialty Code now regulate all of the subject matter encompassed in Chapter 24.95. Therefore, Chapter 24.95 should be repealed to avoid inconsistencies between the City Code and State law.

III. FINANCIAL IMPACT There are no financial impacts anticipated from the proposed code adoptions.

IV. LEGAL ISSUES No issues have been identified or have arisen regarding the proposed code adoptions.

VI. LINK TO CURRENT CITY POLICIES

In order to be consistent with the State Building Code, the City adopts the State Building Codes then in effect and updates the references to those State Building Code provisions in the Portland City Code. The State adopted four new specialty codes covering topics that the Portland Bureau of Development Services administers, including manufactured dwellings, energy efficiency, and solar installations. The sections of the City Code that address these topics are as follows:

- <u>Manufactured Dwellings</u>: Chapter 24.90, Manufactured Dwelling Installation and Accessory Structures, Manufactured Dwelling Parks, Recreational Parks, Park Trailer Installation and Accessory Structures;
- <u>Energy Efficiency:</u> Chapter 24.10, Building Regulations, Administration and Enforcement; and

- <u>Solar Installations:</u> Chapter 27.01, Heating and Ventilating Regulations, Title and Scope, which includes a repealed Section 27.01.035, entitled "Specialty Solar Code." This section was repealed by Ordinance No. 169905, effective April 1, 1996. Section number 27.01.035 is being assigned to the new City Code provision adopting the Oregon Solar Installation Specialty Code by reference.

Proposed City Code revisions to adopt new State specialty codes, including the 2010 Energy Efficiency Specialty Code, the 2010 Solar Installation Specialty Code, the 2010 Manufactured Dwelling Installation Specialty Code, and portions of the 2002 Oregon Manufactured Dwelling and Park Specialty Code pertaining to manufactured dwelling parks; amend Chapter 24.90; and repeal Chapter 24.95.

In 2002, the State adopted a new code entitled, "Oregon Manufactured Dwelling and Park Specialty Code," effective April 1, 2002. The Bureau of Development Services has been administering that code since 2002. In 2010, the State adopted the Oregon Manufactured Dwelling Installation Specialty Code, effective April 1, 2010, which replaced all of the 2002 Manufactured Dwelling and Park Specialty Code, except for the provisions regulating manufactured dwelling parks. The State also adopted two other new specialty codes, the Oregon Energy Efficiency Specialty Code, effective July 1, 2010, and the Oregon Solar Installation Specialty Code, effective October 1, 2010.

ORS 455.040 requires that the State Building Code be uniform throughout the State. The City serves as the local administrator for the State Building Code provisions and has adopted the State specialty codes it administers by reference in the Portland City Code. The Bureau of Development Services currently administers and enforces Building Regulations (Title 24), which includes manufactured dwellings and parks (see Chapter 24.90) and energy efficiency requirements, as well as Heating and Ventilation Regulations (Title 27), which includes solar installations. In order to maintain the City status of code administrator and to maintain consistency with the State Building Codes, the City should add to the applicable chapters of Titles 24 and 27 provisions to adopt by reference the Oregon Energy Efficiency Specialty Code, the Oregon Solar Installation Specialty Code, the Oregon Manufactured Dwelling Installation Specialty Code, and portions of the 2002 Oregon Manufactured Dwelling and Park Specialty Code pertaining to manufactured dwelling parks.

In 1996, the City added Chapter 24.90 to the City Code, which regulates manufactured dwellings and parks. Because Chapter 24.90 was adopted before the State adopted its specialty codes

governing these topics, some provisions of Chapter 24.90 are inconsistent with current State law. Consequently, Chapter 24.90 needs to be amended to eliminate these inconsistencies and make other minor modifications for clarity and internal consistency.

Chapter 24.95 of the City Code, entitled, "Special Design Standards for Five Story Apartment Buildings," is obsolete and inconsistent with State law because the current International Building Code and Oregon Structural Specialty Code now regulate all of the subject matter encompassed in Chapter 24.95. Therefore, Chapter 24.95 should be rescinded.

The attached ordinance accomplishes the State requirements and makes the City Code consistent with the current State Building Code by:

- 1. adding provisions to the applicable chapters of Titles 24 and 27 to adopt by reference the Oregon Energy Efficiency Specialty Code, the Oregon Solar Installation Specialty Code, the Oregon Manufactured Dwelling Installation Specialty Code, and portions of the 2002 Oregon Manufactured Dwelling and Park Specialty Code pertaining to manufactured dwelling parks;
- 2. amending Chapter 24.90; and
- 3. repealing Chapter 24.95.
