ORDINANCE No. 185814

*Amend contract with Travel Portland to extend Downtown Marketing Initiative Contract for an additional four years with an expiration date of June 30, 2017. (Ordinance; amend Contract No. 53081)

The City of Portland ordains:

Section 1. The Council finds:

- 1. On July 7, 2008, the City entered into a contract with Travel Portland for the purpose of promoting, soliciting, procuring, and servicing convention business and tourism.
- 2. The Downtown Marketing Initiative remains a key focus of Travel Portland's portfolio. There is an immediate need to extend Contract No. 53081 for up to an additional four years as permitted by City Charter so that the new expiration date shall be June 30, 2017.
- 3. In order to meet the required Downtown Marketing Initiative's costs, an appropriation of at least \$953,309 each fiscal year until expiration of Contract No. 53081 on June 30, 2017 will be necessary.
- 4. The Bureau's level of confidence in the cost estimates for this project is optimal.

NOW, THEREFORE, the Council directs:

a. That the Commissioner-in-Charge and the Auditor are authorized to approve the amendment substantially in accordance with the amendment and agreed upon Statement of Work attached to the original of this Ordinance and, by reference, made a part hereof, upon approval as to form by the City Attorney's Office.

Section 2. The Council declares that an emergency exists because any unreasonable delay in starting work on the initiative will diminish the effectiveness during the crucial holiday season; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
