ORDINANCE No.

* Authorize application to the U.S. Department of Justice Office on Violence Against Women for a grant in the amount of \$350,000 to fund the proposed BoyStrength program (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Office on Violence Against Women (OVW), a component of U.S. Department of Justice (DOJ), provides national leadership on issues of sexual assault, domestic violence, dating violence and stalking through the implementation of grant programs. On August 28, 2012, the OVW announced a competitive grant solicitation for the Consolidated Grant Program to Address Children and Youth Experiencing Domestic and Sexual Violence and Engage Men and Boys as Allies;
- 2. The City of Portland, Oregon, Police Bureau wishes to apply for \$350,000 in grant funding, which if awarded, would pay for a 1.0 FTE Program Manager; OVW required technical assistance and capacity building activities; and contracts with area professionals to develop BoyStrength program curriculum that focuses on violence prevention, conflict resolution, confidence building, the importance of healthy self-esteem, assertiveness, safety planning and sexual assault and dating violence awareness; and
- 3. The grant period is March 1, 2013, through February 28, 2016.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to make application to the DOJ OVW for a grant in the amount of \$350,000 in accordance with the application attached as Exhibit A.
- b. The Mayor is authorized to provide such information and assurances as are required for the grant period.
- c. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor and to submit required online grant documents on the Mayor's behalf.

Section 2. The Council declares that an emergency exists because delay in proceeding with this application may result in not receiving funding. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
