

ORDINANCE No. 185843

*Pay claim of Lesley Barnes involving Portland Fire Bureau. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Lesley Barnes, through her attorney Jeffrey Bowersox has filed a bodily injury lawsuit against the City for damages suffered in an automobile collision involving the Fire Bureau on December 17, 2009.
2. The claim has been investigated by Risk Management Services. The investigation indicates there is risk the City may be found liable. Therefore, in order to avoid the risk of an adverse jury award, we feel it is prudent to compromise the Lawsuit at this time.
3. Risk Management Services recommends the Lawsuit be compromised for the sum of \$4,000 in addition to payments previously made to Ms. Barnes' insurer State Farm subject to the claimant providing the City with a release in a form to be approved by the City Attorney.

NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver a check in the amount of \$4000 made payable to Lesley Barnes and Bowersox Law Firm, P.C.
- b. Risk Management Services will execute a payment authorization in the amount set forth in sub-paragraph (a) above.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this Lawsuit; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
