ORDINANCE No. 185864

* Amend Intergovernmental Agreement with Multnomah County Department of County Human Services to add funds for flexible client assistance for Veterans. (Ordinance; amend Contract No. 30002899)

The City of Portland ordains:

SECTION 1. The Council finds:

- 1. Through Ordinance No. 185677 the Council authorized an Intergovernmental Agreement (IGA) No. 30002899 between the Multnomah County Department of County Human Services (County) and the City of Portland Housing Bureau (City) to provide \$76,875 in County general funds for flexible outreach and housing placement to people experiencing homelessness in incorporated and unincorporated areas of Multnomah County east of the Portland city limits (East County) between August 1, 2012, and June 30, 2013.
- 2. The County has initiated an amendment (Exhibit A) to the existing IGA to add \$10,000 in County general funds for flexible client assistance for Veterans.
- 3. The above stated services meet the goals and objectives of the City.
- 4. The County has authorized the City to subcontract the work and funds associated with the amended IGA, and the City intends to subcontract all work and funds through a FY 2012-2013 contract.

NOW, THEREFORE, the Council directs:

- a. The Bureau Director and the City Auditor are authorized to execute Amendment No. 1 to the Intergovernmental Agreement between the City and the County, attached as Exhibit A: and amend the agreement with JOIN for the purpose described above.
- b. The Mayor is hereby authorized to accept on behalf of the City payments of up to \$86,875 from the County as specified in the IGA.
- The Portland Housing Bureau is authorized to perform all administrative matters in relation to the IGA, requests for reimbursement from the County, and to submit required reporting on the Mayor's behalf.

SECTION 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the IGA; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
