ORDINANCE No. 185881

Accept a grant in the amount of \$48,707 from the Oregon Military Department, Office of Emergency Management for the sustainment of a Community Emergency Notification System. (Ordinance)

The City of Portland ordains:

Section 1. The Council Finds:

- 1. On September 5, 2012 the City of Portland passed Ordinance 185588, authorizing the Bureau of Emergency Management (PBEM) to apply to the Oregon Military Department, Office of Emergency Management for a grant from the State Homeland Security Grant Program (SHSGP)
- 2. The Oregon Military Department, Office of Emergency Management has notified the City of Portland that it will award an SHSGP FY 2012 grant to PBEM in the amount of \$48,707 for the continued funding of a Community Emergency Notification System in the 2013-14 fiscal year.
- 3. No match is required by this grant.

NOW THEREFORE, the Council Directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland an SHSGP FY 2012 grant from the Oregon Military Department, Office of Emergency Management for the continued funding of a Community Emergency Notification System in the amount of \$48,707
- b. The FY 2012/2013 budget is hereby amended as follows:

GRANTS FUND Fund 217 Business Area – EM Bureau Program Expenses – \$0

c. The Office of Management & Finance Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.

d. The Director of PBEM is authorized to accept on behalf of the City of Portland any subsequent modifications by the Oregon Military Department, Office of Emergency Management for the SHSGP FY 2012 grant, award number 12-226, provided such modifications do not increase the City of Portland's financial obligation or risk. Any modifications that increase the City of Portland's financial obligation or risk must be authorized by the Portland City Council.
