Adjust the date for the Portland Police Chief's report on the Portland Police Bureau work with the Federal Bureau of Investigation Joint Terrorism Task Force. (Resolution)

WHEREAS, Resolution 36859 directs the Chief of Police to provide a report with appropriate public information to the City Council and public by the end of January each year on the Portland Police Bureau's work with the Federal Bureau of Investigation's Joint Terrorism Task Force, including any issues related to compliance with Oregon laws.

WHEREAS, As the newly elected Mayor has only been in Office since the beginning of January, he and his staff request more time to meet with the Police Bureau and the Federal Bureau of Investigation in order to become better informed of the Joint Terrorism Task Force agreement.

NOW, THEREFORE, BE IT RESOLVED, That the deadline for the current Portland Police Chief's second public report on the Portland Police Bureau's work with the Federal Bureau of Investigation's Joint Terrorism Task Force be extended to the end of March, 2013 and in subsequent years.


