## ORDINANCE No. 185939

\*Authorize a contract with the lowest responsible bidder for the SW Vermont-Illinois Neighborhood Greenway (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- In 2011, the Portland Bureau of Transportation (PBOT) began work in conjunction with the Bureau of Environmental Services on four stormwater intersection improvements at SW Vermont/Idaho Drive, SW Vermont/Capitol Highway, SW Chestnut/Terwilliger, and SW 7<sup>th</sup>/Terwilliger.
- 2. In 2012, PBOT working with stakeholders added sidewalk improvements to the plans on SW Vermont from SW 30<sup>th</sup> to SW 37<sup>th</sup>.
- 3. PBOT is approaching final plans, specifications, and estimates for the project and is seeking to bid the project before the end of the current fiscal year.
- 4. The Bureau of Transportation has funds budgeted in FY 12-13 and proposed FY 13-14 for construction, inspection and management of the project.
- 5. The Bureau's level of confidence in the cost estimate for this project is moderate because the project is defined and plans and specifications are nearing completion.

## NOW, THEREFORE, the Council directs:

- a. Upon the Council's acceptance of the Chief Procurement Officer's report recommending the lowest responsible bidder, the Chief Procurement Officer is authorized to negotiate and execute a contract, provided the contract has been approved as to form by the City Attorney's office.
- b. The Auditor to draw and deliver warrants chargeable to T00225 or 7TRES0001073, as appropriate, when demand is presented and approved by the proper authority.

Section 2. The Council declares that an emergency exists because the project is seeking to advertise for bids before the year end procurement deadline; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
