

ORDINANCE No. 185953

Authorize a contract for the construction of the SW Capitol Hwy and SW Vincent Place Sewer Replacement Project No. E10300 at an estimated cost of \$983,800 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Approximately 371 feet of public combined and sanitary sewer in the vicinity of the intersection of SW Capitol Hwy and SW Terwilliger Blvd, are severely deteriorated and need to be replaced.
2. Environmental Services has prepared plans and specifications and has obtained permits for replacing the deteriorated sewer pipe, including manholes, stormwater inlets, and abandonment of replaced pipe.
3. The estimated cost is \$983,800. Level of confidence in this estimate is high. Funds are available in the Sewer System Operating Fund, FY 2013 Budget, Bureau of Environmental Services, WBS Element E10300.C60.

NOW, THEREFORE, the Council directs:

- a. The Mayor is authorized to execute a contract for the purpose described in Section 1.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.


