185956 Ordinance No.

*Amend right-of-way agreement granted to T-Mobile West Corporation, Inc. to clarify remittance dates for annual payments. (Ordinance; amend Ordinance No. 185790)

The City of Portland ordains:

Section 1. The Council finds:

- 1. On December 12, 2012, the Council approved a right-of-way use agreement for T-Mobile West Corporation, Inc. (T-Mobile) to build and operate wireless facilities within the City's streets. Ordinance No. 185790. The Ordinance renewed T-Mobile's authority to occupy the City's right-of-way for an additional 5 year period and established terms and conditions for the use of the right-of-way.
- 2. It is necessary to amend the Ordinance to provide clarification on the remittance dates for the proper and effective administration of T-Mobile's annual payments.

NOW THEREFORE, the Council directs:

- a. Section 3.B.1 and Section 3.B.2 shall be replaced with the following:
 - B. Remittance Dates.
 - 1. Grantee shall pay the greater of the Minimum Annual Fee or the aggregate of the Right-of-Way Use Fees for all Grantee's sites in the Right-of-Way on or before each May 15. The remittance shall be for the previous calendar year ending December 31.
 - 2. For any Attached Facilities occupying the Right-of-Way for less than a full year, Grantee shall pay the prorated Right-of-Way Use Fee on or before May 15 of the following year after the date of installation or removal.
- b. All other conditions and terms of Ordinance No. 185790 shall remain unchanged.

Section 2. The Council declares an emergency exists because further delay impacts the effective administration of T-Mobile's right of way use agreement and fees to the City general fund to the detriment of the public welfare; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
