

ORDINANCE No. 185973

*Authorize a contract with the lowest responsible bidder for the SW Multnomah Blvd Improvements: SW 22nd Ave to SW 40th Ave (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. In the fall of 2011, the Portland Bureau of Transportation worked with the Multnomah Neighborhood Association to develop a design concept for improving pedestrian and bicycle facilities on SW Multnomah Blvd.
2. The Bureau of Environmental Services and Portland Bureau of Transportation (PBOT) agreed to partner on funding for the project.
3. This project is identified in the City's Capital Improvement Program (CIP).
4. The Bureau of Transportation has funds budgeted in FY 2012-13 and proposed FY 2013-14 for construction, inspection and management of the project.
5. The Bureau's level of confidence in the cost estimate for this project is moderate as the project scope is clearly understood and well defined.

NOW, THEREFORE, the Council directs:

- a. Upon the Council's acceptance of the Chief Procurement Officer's report recommending the lowest responsible bidder, the Chief Procurement Officer is authorized to negotiate and execute a contract, provided the contract has been approved as to form by the City Attorney's office.
- b. The Auditor to draw and deliver warrants chargeable to T00245.C42 when demand is presented and approved by the proper authority.

Section 2. The Council declares that an emergency exists because it is important to advertise this project as soon as possible to begin construction of pipe work before winter season and periods of high water; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.



