Amend contract with Brown and Caldwell, Inc., for additional work and compensation for the SW Multnomah Blvd Stormwater Improvements – 35th to 40th Aves. Project No. E10242 for \$34,559.00 (Ordinance; amend Contract No. 30002665)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Bureau of Environmental Services (BES) has need of continuing professional engineering services provided by Brown and Caldwell, Inc. (B&C) for required SW Multnomah Blvd Stormwater Improvements.
- 2. B&C is continuing to provide professional engineering services under Contract No. 30002665 effective May 1, 2012 with an expiration date of October 30, 2013.
- 3. The estimated cost of this contract amendment is \$34,559. Funds are available in the Sewer System Operating Fund, FY 2013 Budget, and BES Project No. E10242. The level of confidence in the negotiated cost for the proposed amendment 2 to contract No. 30002665 with B&C is high.
- 4. M/W/ESB participation after the authorization of contract amendment 2 will be \$12,000, 11.8% of the amended contract amount of \$101,559.

- a. The Commissioner in Charge is authorized to execute amendment 2 to contract 30002665 with Brown and Caldwell, Inc. for the purpose described in Section 1, in the amount of \$34,559.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
