

ORDINANCE No. 185992

Authorize an agreement with AT&T Corp. for the NE 33rd Drive Culvert Project No. E10377 for an estimated amount \$58,310 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Environmental Services is undertaking an approved project to replace an existing culvert with a new culvert at the Buffalo Slough at NE 33rd Drive.
2. Part of the work involves relocation of utilities. AT&T has fiber optic conduits in NE 33rd Drive that need to be relocated. When AT&T originally installed their conduits, they also installed conduits for the City of Portland. The City wishes to enter into a cost-sharing agreement with AT&T so that the City's conduits can be relocated by AT&T at the same time AT&T's conduits are relocated.
3. AT&T has indicated that the City of Portland's share of the relocation cost will be \$58,310. Funds are available in the Sewer System Operating Fund, FY13 Budget, Bureau of Environmental Services, WBS Element E10377.C60.

NOW, THEREFORE, the Council directs:

- a. The Director of the Bureau of Environmental Services is authorized to enter into a cost-sharing agreement with AT&T, said agreement to be substantially in conformance with the critical terms and financial obligations described in the attached draft agreement.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.

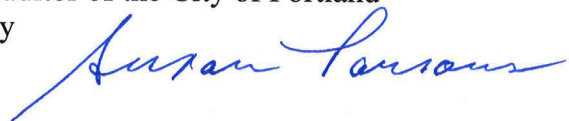
