

## ORDINANCE NO. 186077

\*Authorize a grant agreement with Oregon Community Warehouse, Inc. dba Community Warehouse, an Oregon nonprofit corporation, in the amount of \$24,000 to provide household goods and furniture to families and individuals in need throughout the City (Ordinance)

The City of Portland ordains:

### Section 1. The Council finds:

1. Families and individuals throughout the City of Portland have a need of basic household items on a daily basis.
2. Oregon Community Warehouse Inc. ("Community Warehouse") is a local nonprofit that collects and distributes donated furniture and household goods to people in need, including families escaping domestic violence, older adults, people with mental and physical disabilities, refugee families, youth and adults recovering from substance abuse, individuals and families moving out of homelessness, and the working poor.
3. In 2012, Community Warehouse served 2,000 families in the City.
4. Community Warehouse supports our community's safety net by helping vulnerable populations improve the quality of their lives and become self-sufficient by providing them with basic household furnishings.
5. Community Warehouse acts as a conduit between neighbors – those in possession of used goods and furniture and those who are in need and can put those items to use.
6. Community Warehouse furthers the sustainability values of the City by reusing about 450 tons of usable household goods and furniture annually, keeping many of those items out of local landfills.
7. The amount of this grant will be \$24,000.00.

NOW THEREFORE, The Council directs:

- a. The City of Portland designates and authorizes the funding contained in this ordinance to be a grant. The Chief Procurement Officer is authorized, on behalf of the City, to enter into a Grant Agreement with Community Warehouse as substantially set forth in Exhibit A attached to this ordinance.

- b. \$19,000 will come from the 2012-13 budget allocated for the Commissioner of Public Safety. \$5,000 will come from the 2012-13 budget allocated for the Commissioner of Public Works.
- c. The Mayor and Auditor are authorized to draw and deliver checks to Community Warehouse, chargeable to the FY 2012-13 General Fund Budget as indicated above.

Section 2. The Council declares that an emergency exists because the need in the community is great and these funds are available now. Therefore this ordinance shall be in full force and effect from and after its passage by the Council.
