

ORDINANCE No 186078

*Authorize an Intergovernmental Agreement with the Portland Development Commission for Federal and State Lobbying activities (Ordinance)

The City of Portland ordains:

Section 1. The Council Finds:

1. By the authority granted in ORS 192.010 et al. units of local government may enter into an agreement with each other for the performance of any or all of the functions and activities that a party to the agreement has the authority to perform.
2. OGR frequently performs functions that assist PDC with federal and state legislative matters which directly advance priorities in the PDC Strategic Plan.
3. OGR has provided assistance linking federal elected officials to PDC's cluster strategy and neighborhood economic development initiatives through briefings and appearances at forums and roundtables.
4. OGR has provided assistance with tracking urban renewal legislation; facilitating state approval for PDC's expanded use of the Enterprise Zone program; and other legislative matters.
5. In 2013-14 PDC will seek OGR assistance for agency priorities such as the federal EB-5 program, and other work centered on PDC's emerging business lines.
6. Funding has been appropriated in the City's FY 2013-14 budget to fund the above mentioned activities.
7. Both parties desire to enter into an Intergovernmental Agreement (IGA), attached as Exhibit A

NOW THEREFORE, the Council directs:

- a. The City of Portland, Office of Government Relations, is authorized to execute an intergovernmental agreement with the Portland Development Commission, in a form substantially similar to the contract attached as Exhibit A, and by reference made a part hereof.
- b. The City Attorney shall approve as to form all amendments prior to their execution.

Section 2. The Council declares that an emergency exists because the IGA includes funds that were approved in the Council's FY 2013-14 budget and, therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.


