

# ORDINANCE No. 186146

\*Authorize a five year contract with Net Assets Corporation in a not to exceed amount of \$1,250,000 to provide online access of the City's lien docket, as required by Oregon Revised Statutes (Ordinance; Contract No. 30003264)

The City of Portland ordains:

Section 1. The Council finds:

1. In accordance with ORS 93.643 the City is required to record certain liens in the County Clerk's office, or provide public access to the lien information through an online electronic medium.
2. On February 20, 2002, City Council passed Ordinance No. 176279, authorizing the Auditor's Office to negotiate and execute a contract with Net Assets Corporation of Eugene, Oregon, to provide online access to the City's municipal lien docket information. Contract No. 51731 was entered into with an effective date of February 11, 2002.
3. Net Assets has developed a program, Conduits, which provides this service to many other municipalities in the State of Oregon in order for them to provide public online access to lien information. Subscribers, such as title companies, escrow agents, financial institutions, and real estate professionals, may utilize the online program to perform lien searches as part of real estate transactions or other research.
4. Presently the City uses the Conduits program and charges subscribers a fee, established by the Auditor's Office. These charges recover the full amount paid by the City to Net Assets for use of the Conduits program, as well as administrative costs of the City's lien assessment program administered by the Auditor's Office.
5. The City wishes to continue having support for making the online lien docket information available in accordance with ORS 93.643. Under this contract, Net Assets will continue to provide the online application and services.
6. This Ordinance authorizes a contract with Net Assets for a term of up to five years, with a not to exceed value of \$1,250,000.00, and with the City's option to terminate the contract for convenience upon sixty days' written notice to Net Assets.

NOW, THEREFORE, the Council directs:

- a. The City's Chief Procurement Officer is hereby authorized to execute a contract in a form substantially in accordance with the contract attached as Exhibit A.

Section 2. The Council declares that an emergency exists because the City needs to remain in compliance with state law and to ensure there is no lapse in providing online access to lien docket information. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
