*Amend Legal Services Agreement with Radler White Parks and Alexander LLP for outside legal counsel (Ordinance; amend Contract No. 30002710)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The City required the services of outside legal counsel regarding the siting and construction of the Fanno Creek Pump Station.
- 2. The law firm of Radler White Parks and Alexander LLP agreed to provide these services by Legal Services Agreement No. 30002710
- Because specialized legal advice is still required for the project, it is 3. necessary to increase the amount of the agreement and extend the terms by two years.

NOW, THEREFORE, the Council directs:

- The City Attorney is authorized to extend Legal Service Agreement No. a. 30002710, dated July 01, 2012, to provide for representation by outside counsel in an additional amount of \$50,000, for a total not to exceed \$125,000.
- b. The terms of the agreement are extended to June 30, 2015.
- If applicable, the provisions of City Code Chapter 5.68 are waived. C.
- d. The Mayor and Auditor are authorized to draw and deliver checks in payment of legal services provided under this Legal Services Agreement.

Section 2. The Council declares that an emergency exists in order to continue to pay for legal services in a timely manner in the matter of the Fanno Creek Pump Station. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
