Authorize a contract for construction of the Vernon-Sabin-Alameda Phase 2 Sewer Rehabilitation Project No. E10379 for \$3,100,000 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- Approximately 10,030 feet of combined and sanitary sewer pipe in NE Alameda neighborhood between NE Alameda St and NE Siskiyou St from NE 20th Ave to NE 31st Ave are in severely deteriorated condition and need to be replaced.
- 2. Environmental Services has prepared plans and specifications for replacing the deteriorated sewer pipe including sewer manholes, service laterals, and stormwater inlets.
- 3. The estimated cost is \$ 3,100,000. Level of confidence in this estimate is high. Funds are available in the Sewer System Operating Fund, FY 2014 Budget, Bureau of Environmental Services, WBS Element E10379.C60.

NOW, THEREFORE, the Council directs:

- a. The Commissioner in Charge is authorized to execute a contract for the purpose described in Section 1, with the lowest responsive bidder.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
