- WHEREAS, the Oregon Legislature has passed legislation allowing local jurisdictions to forgo a portion of property tax revenue for a defined period of time as an incentive for the development of housing that achieve larger city policy goals;
- WHEREAS, on behalf of the City of Portland, the Portland Housing Bureau administers the Nonprofit Corporation Low Income Housing Tax Exemption Program authorized under ORS 307.540 to 307.548 and Portland City Code 3.101;
- WHEREAS, pursuant to ORS 307.547 a determination must be made by the governing body certifying to the County Assessor that the applicant(s) qualifies for exemption under ORS ORS 307.540 to 307.548; and
- WHEREAS, the properties included the attached Exhibit A have been determined to be eligible to receive the property tax exemption pursuant to ORS 307.540 to 307.548 and Portland City Code 3.101.
- NOW, THEREFORE, BE IT RESOLVED, that the properties included in Exhibit A are hereby certified as qualified for exemption from taxation under ORS 307.540 to 307.548 for one (1) tax year beginning July 1, 2013 and ending June 30, 2014.
