

ORDINANCE No. 186227

* Accept and appropriate a grant in the amount of \$25,000 from and authorize a Letter of Understanding with the Oregon Department of Justice Criminal Justice Division for sworn personnel overtime for domestic cannabis eradication and suppression efforts (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Police Bureau applied to the Oregon Department of Justice (ODOJ) Criminal Justice Division for grant funding to support cannabis eradication and suppression efforts in the Portland-Metropolitan area;
2. The U.S. Drug Enforcement Administration provides funding to ODOJ in support of Domestic Cannabis Eradication/Suppression Programs (DCE/SP) in Oregon;
3. The ODOJ Criminal Justice Division has notified the City that it will award a grant for cannabis eradication and suppression to the Police Bureau in the amount of \$25,000. The grant period is January 1 - December 31, 2013;
4. The ODOJ will reimburse the City a maximum of \$25,000 for investigative overtime associated with eradication and suppression missions;
5. No match is required for this grant; and
6. Council declares an emergency exists because a delay would jeopardize the awarding of the grant funds from ODOJ.

NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City a grant from the Oregon Department of Justice for the 2013 DCE/SP in the amount of \$25,000 and to execute the Letter of Understanding in substantially the form of the attached exhibit for this purpose.
- b. The Mayor and City Auditor are hereby authorized to execute the Letter of Understanding with the ODOJ acting by and through its Criminal Justice Division in substantially the form of the attached exhibit for this purpose.
- c. The FY 2013-14 budget is hereby amended as follows:

- d. The Office of Management & Finance Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.
 - e. The Chief of the Police Bureau of the City of Portland is authorized to accept on behalf of the City of Portland any subsequent modifications by the Oregon Department of Justice for the 2013 DCE/SP, LOA #2013-112, provided such modifications do not increase the City of Portland's financial obligation or risk. Any modifications that increase the City of Portland's financial obligation or risk must be authorized by the Portland City Council.

Section 2. The Council declares that an emergency exists because a delay would jeopardize the awarding of the grant funds from ODOJ. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.


