

ORDINANCE No. 186287

*Authorize a contract with BNSF Railway Company for access on BNSF Railway property at N Columbia Blvd at mile post 6.91 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds that:

1. The purpose of this Agreement is to allow access on BNSF Railway property to work on the City of Portland bridge at N. Columbia Blvd at mile post 6.91.
2. A structural upgrade to the bridge is required per the biannual bridge inspection to prevent bridge from being load restricted. Work will be completed by the Bureau of Transportation, Maintenance Operations.
3. Authorization to work over the BNSF Railway requires a permit from the railroad.
4. This Agreement will require a BNSF contract fee of \$1000.00 to access their property. The fee is budgeted within 9TR000000740 as part of the project work.

NOW, THEREFORE, the Council directs:


- a. The Mayor and the City Auditor are authorized to enter into an agreement with BNSF Railway Company for access on BNSF Railway property, in a form similar to the contract attached as Exhibit A.
- b. City Council authorizes the Bureau of Transportation Director to sign time extensions to the agreement if necessary.

Section 2. The Council declares an emergency exists due to the need for structural upgrade to the bridge to eliminate future truck weight restrictions; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
