

ORDINANCE No. 186342

Authorize a contract and provide payment for construction of the Interstate 5 at SW 26th Water Quality Facility, Project No. E08679 for \$2,600,000. (Ordinance).

The City of Portland ordains:

Section 1. The Council finds:

1. On March 8, 2006, the City Council adopted the 2005 Portland Watershed Management Plan, including actions to improve stormwater management for water quality and in-water habitat enhancement for salmonids. The Interstate 5 project was identified in the Plan and refined in the Fanno/Tryon Water Quality and TMDL Predesign completed in 2008. On May 2, 2012, Council adopted Resolution #36920, reaffirming the City's commitment to watershed health.
2. This project is being designed and constructed under terms of the Master Intergovernmental Agreement (184384), between City of Portland and the Oregon Department of Transportation (ODOT) to retrofit stormwater facilities of mutual interest within the City's jurisdictional areas.
3. Environmental Services has prepared plans and specifications for constructing tiered stormwater treatment systems to provide treatment and detention of stormwater runoff from City and ODOT managed properties prior to discharge to Tryon Creek.
4. The estimated construction cost is \$2,600,000. The level of confidence is high.
5. Funds are available in the Sewer System Operating Fund, FY 13/14 and 14/15 Budget, Bureau of Environmental Services, WBS Code E08679, Account No 549000. The Oregon Department of Transportation will reimburse the City for \$1,487,000 of the construction cost through the Master Intergovernmental Agreement (184384).

NOW, THEREFORE, the Council directs:

- a. The Commissioner in Charge is authorized to execute a contract with the lowest responsible bidder for the purpose described in Section 1.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
