a) What impacts are anticipated in the community from this proposed Council item?

Enhanced understanding and clarity of PCC sections related to BES reviews of permits. Expansion of permit types to capture minor activities such as changing plantings in onsite stormwater management facilities or encroachment into City sewer or drainage easements with less regulatory and cost burden then the limited permit options currently available. These minor changes are not anticipated to have any community impact.

This code package was developed by staff from BES and the City Attorney's Office.

The proposal has been listed for over 4 months on the DRAC code and rules action sheet.
