### Purpose of proposed legislation and background information:

Metro has provided funding to run the Waste Reduction Program since 1990. BPS uses the Metro Waste Reduction Challenge funds to support outreach efforts to increase participation in the commercial and residential recycling and composting programs. The ongoing Recycle at Work funding is used to support outreach and technical assistance to Portland businesses to promote waste prevention and recycling activities. These programs and services are critical to meeting higher recycling goals set in the 2015 Climate Action Plan.

#### Financial and budgetary impacts:

The funding has appropriated \$682,237 in the FY 2016-17 Adopted Budget for the Bureau of Planning and Sustainability. Changes in the appropriations are described in the table below to reflect actual award amount. No City match is required for these funds. No positions will be created, eliminated or re-classified as a result of this legislation.

#### Community impacts and community involvement:

Public involvement was not necessary and is not anticipated to support the authorization of this ongoing funding support from Metro. However, the public was involved in the development of Metro's budget, as well as the two plans that guide the work that is funded through this grant: the 2015 Climate Action Plan and the 2008 Portland Recycles! Plan. Each of the plans involved public engagement efforts such as community meetings and gathering public comment through surveys and forms.
