ORDINANCE No. 188050.

*Authorize the acquisition of 12 acres of real property on NW 4th Place, adjacent to Forest Park, for \$860,000 to be used for Park purposes. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. In accordance with the terms and conditions of a Purchase and Sale Agreement (Agreement) dated June 27, 2016, authorized by Ordinance 180626 and 181710, Portland Parks & Recreation (Parks) wishes to purchase a 12 acres property located at 10615 NW 4th Place, also referred to as R323835. (Property).
- 2. The Property, adjacent to Forest Park, has expansive views of the city and contains mature oak habitat and two streams.
- 3. Once acquired this Property will be added to Forest Park.
- 4. The purchase price of the Property is \$860,000, which will be paid with Parks System Development Charge funds and with funds from Parks' Local Share of the 2006 Metro Natural Areas Bond.
- 5. It is estimated that on-going O&M costs will be approximately \$25,000 per year. An O&M request will be made through the FY 2017-18 budget process.

NOW, THEREFORE, The Council Directs:

- a. The Director of Parks is authorized to execute all closing documents and take all other actions, including executing related easements, necessary to close the transaction in accordance with the Agreement and any amendments thereto. All documents will be approved as to form by the City Attorney prior to execution;
- b. The Director of Parks is directed to deposit the purchase price and closing costs into an escrow account established for the purpose of the acquisition of the Property. Such payments shall be made using Parks SDC funds and Metro Natural Area Bond funds;
- c. The Director of Parks is directed to add the Property to the City's Park inventory upon closing;

Section 2. The Council declares that an emergency exists in order to avoid further delay in the acquisition of the Property; therefore, this Ordinance shall be in force and effect from and after its passage by Council.
