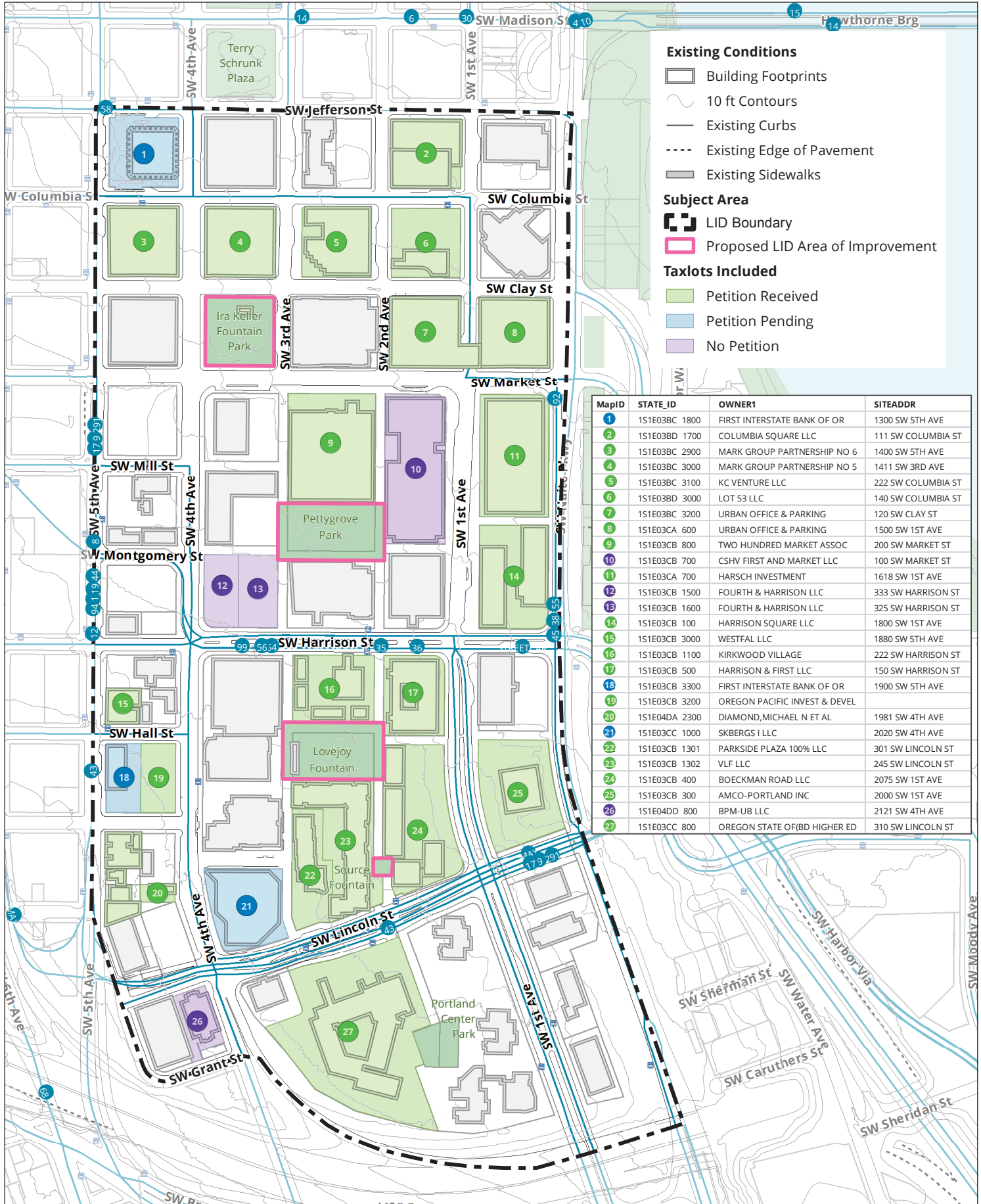




Open Space Sequence LID Map
