I want to thank Nick Fish and Amanda Fritz for bringing the sale of Terminal 1 back to the table. Since August, you have had LUBA provide negative rulings that impact putting shelters on industrial land. A prominent attorney accused the city of subsidizing this land on the dollar of rate payers. To make matters worse, Homer Williams chose a man that hasn't run a mass shelter to run it and proceeded to suggest an open model which was a direct contradiction to what he told the public at his unveiling of Harbor for Hope. Ultimately, this plan is not vetted enough to pass on the sale of a property that immediately put <u>\$10</u> to \$12M back into the hands of rate payers while creating both jobs and tax revenue. The homeless situation is a difficult one to solve, but it is also a delicate one that requires proper planning and an integrated plan. Haven for Hope looks good on paper, but it has shown to be an expensive program that is less effective than Portland's own programs like Central City Concern. Please make the sound decision you passed on a few months ago. You have more information and it is time to make a decision based on that information.

City Council,

As the city cleans up Springwater Corridor, I don't have to tell you the count of hypodermic needles, gallons of urine, gallons of fecal matter nor how many dumpsters of garbage were found. You already know these numbers. You also already know, this was more than Lents or any one community should of had to bare for even a week. As soon as the news of Terminal One got out the needles, urine and fecal waste found its way to my neighborhood. Aimee Sukol would call me a NIMNBY, while she complains about a few homeless in her own neighborhood, to the Portland Business Journal. This isn't true though. I brought my office to downtown, on Naito, just north of the Steel Bridge in 2006. Several homeless have lived near there, under the bridge and other parts of Old Town long before I got there. This did not stop me from putting an office 250 feet from there and I never had any problems. That is until the camping was allowed and encouraged under the Steel Bridge. For the safety of my staff and clients who came to see me at my office I had to start locking my doors during business hours. Now things are back to normal at my office. What this proved to me is many homeless in one place leads to bad people easily finding vulnerable homeless (drug addicted or mentally ill) and things get out of control. Many other business had to start locking their doors as well during that time.

Portland needs many things. It needs a solution or at least a path to move on with homeless. It needs more housing to end the plight of those going homeless due to affordability of housing and we need jobs. There is more to the list, but these we know are up there.

That said, why would we consider a warehouse with no heat and not enough bathrooms for even a temporary shelter? Why would we consider a building that could be sold for more than it was listed for? Why would we consider a site that is right next to hundreds of much needed apartments ABOUT to be finished? Why now that Port of Portland is gone would we not see T1 as as avenue for growth of jobs and housing, as again once you put a homeless shelter there, no one will be as interested in the properties next to it. Why? We need the affordable housing measure. We need some of these houses in everyone's neighborhood, and small shelters of 25 or less homeless in each neighborhood so we all take the responsibility with out all the pain. We need to not group 100 or more homeless together. Haven for Hope, the model for T1 gets 2.5 police responses a night. More to the surrounding neighborhood. Why put that in anyones neighborhood? Near a school? Why take hundreds of thousands of dollars off of anyone's net worth? Don't we need both prosperity and solutions? Can we have solutions if no one is able to fund them? No one should have to regret investing in Portland. If we want real change we have to see both sides of this issue. Please sell terminal 1.

City council member,

I am writing to urge you to rescind resolution 37225 tomorrow in your city council meeting.

I testified to city council in August that I had concerns about the physical safety of the space. These concerns have been reinforced in the last two months, with DEQ confirming concerns about the environmental contaminants in the space that should make the space unfit for human residency, and with former T1 workers citing structural damage to the supporting structures and roof. Homer Williams has not included remediation of these issues in his Oregon Harbor for Hope plans, and therefore the concerns remain. An industrial application for the space would be more appropriate to alleviate these concerns.

Further, the city's own comprehensive plan states that industrial space - particularly riverfront industrial space - is lacking in the area. This space should not be sacrificed to a non-industrial use, as the city needs to be able to attract jobs and industry to the area to support Portland's massive predicted growth rate.

I strongly urge you to rescind Resolution 37225 and authorize the Bureau of Environmental Services to sell Terminal 1.

The sale plus annual revenue from property taxes/business taxes in such a prime area, would be a huge boon for the city. A much needed revenue source if we are indeed to tackle the homeless situation in Portland on a long term basis.

Instead of creating one large facility in one area, much better to create smaller facilities and spread them in different parts of the city.

This way, no single neighborhood will be unfairly impacted. With smaller facilities in different areas, 1) existing neighborhood residents can better absorb the impact that a homeless shelter will bring. And 2) it's less likely to create a situation of *white flight*.

Finally, it seems much more humane for people who are homeless to be housed in human size facilities. With the many problems that some homeless people face—sexual assault, drugs, mental illness, trauma, it seems unsafe and unwise to lump them all together in one huge facility such as has been proposed.

Please rescind Resolution 37225.

I appreciate the desire to take advantage of private investment in handling the homeless situation. I'm glad that you developed a private relationship to improve the type of homeless shelter options there are in this city. When Terminal 1 was originally selected, I had concerns that due diligence was not done. How could a superfund site with no plumbing or heating be picked? The reality is that the options weren't good and I want to congratulate you for developing a private option.

With Winkler Development's affordable housing offer and Tom Cody's offer of temporary shelter space, there appears to be a lot of solid work being done. It's also obvious that limiting the choice of this option to Terminal 1 makes little sense. This land can create immediate revenue to the city and high paying industrial jobs. The Unions and businesses around the area favor the sale of this property. Unlike San Antonio's Haven for Hope, the neighborhood around Harbor for Hope does not average 50 to 60k in value. This neighborhood has had significant investment in business and apartment buildings within a ½ mile of the proposed site. It's time to follow the comprehensive plan and sell Terminal 1.

Dear Mayor and commissioners,

While I appreciate the issues around the homeless in this town, it is becoming glaringly obvious that the decision to forego the sale of Terminal 1 was a mistake. Since the ruling, you have done a good job of establishing private relationships with Tom Cody to secure shelter space. Unfortunately, Homer's inability to get shelter space ready at Terminal 1 in the winter and the recent feedback on the effectiveness of Haven for Hope vs. current programs has led me to believe that it is time to sell Terminal 1. It's fairly obvious that resources with Central City Concern have eclipsed Haven for Hope's track record. Portland housing program has housed 3,500 individuals in the past year vs. Haven for Hope's 4,500 in 7 years. While I appreciate Homer's desire to help, it looks like he needs time to develop an appropriate plan.

It's time to acknowledge the legal issues with LUBA and the ratepayers. It is time to acknowledge that Terminal 1 can create high paying, industrial jobs and tax revenue for the city. It is time to acknowledge that \$10 to \$12M paid to the rate payers on sewage bills would be a win to tax payers. With the current ask of the city to provide \$258M for affordable housing program, the only concern I have is the ability of the council to make sound financial decision on housing programs. Please show you will do a sound financial decision and open Terminal 1 for sale. Otherwise, I will likely consider this in my ballot. It is time to make the right financial decisions rather than wasting money on programs like R2D2's move to the eastside and Terminal 1.

Selling the property at Terminal 1 for industrial use will create high paying industrial jobs that the city needs and will help fulfill the goals outlined in the <u>Comprehensive Plan</u> adopted in June of this year. Money from the sale could be returned to water and sewer rate payers and the jobs created would provide tax revenue for the city.

This property is zoned for industrial use for a reason. The soil is <u>contaminated</u> and much of it sits atop <u>rotting</u> <u>timber</u>. A <u>former facility engineer for the Port of Portland wrote that</u> "people will die" as portions of the property sit on a timber structure on the river that "contained major amounts of dry rot and were too expensive to fix." Building a massive transitional housing project at this location would be costly and ineffective.

We've learned from San Antonio's mass shelter that it costs a lot of money ( $\frac{100+ \text{ million for construction} + \frac{14 \text{ million per year to operate}}{14 \text{ million per year to operate}}$  and increases crime in the surrounding area. As for effectiveness, here are the <u>Point In Time counts</u>:

- 2009: 1,107 (Total Persons Unsheltered)
- <u>2010</u>: 1,617 (the year Haven opened)
- <u>2011</u>: 1,176
- 2012: 1,627
- <u>2013</u>: 1,243
- <u>2014</u>: 922
- <u>2015</u>: 1,158
- <u>2016</u>: 1,137

We know what works for homelessness: providing secure, affordable housing to those most in need ("Housing First"). Portland has a shortage of affordable housing (the rental vacancy rate is 2.2%). If you put 1,400 people in a mass shelter, where would they go after that? It's a dead end.

I urge you to rescind resolution 37225, put the property back on the market and support industrial job creation that will help potentially hundreds of individuals and our city.

I have witnessed the details of Harbor For Hope develop and fall far short of the proclaimed vision stated initially when Resolution 37225 was passed. I've personally interviewed experts on homelessness, and was informed a massive shelter is not a proven successful model, and is questionable legal. Currently the Supreme Court is hearing testimony regarding similar massive shelters and the overwhelming belief is that our country's highest court will deny such options. Homelessness is a rampant problem in our country & many cities are similarly grappling with ways to manage the situation. Please responsibly spend the Portland taxpayer's money in a manner actually shown to yield results -- dispersement throughout the city.

At a time when job-creation has never been more critical, please release Terminal 1 back to the market so industrial jobs may create income for families, releasing them from the downward pull towards homelessness.

Please listen to citizens who have bravely pioneered the city's robust build-out North and invested their life's savings into the waterfront property, creating a safe, welcoming neighborhood that has begotten more growth and development. This is the type of citizen involvement the city should honor and encourage.

Allow your citizenry to engage, and please listen to our voices -- we want to find a responsible, creative, and humane solution to Portland's homelessness issues and we are actively engaged in this issue; however, we will not tolerate irresponsible, inhumane, and 'shot gun' plans which repulse the very creative industries that generate more jobs & economic stimulation.

As you are well aware, there are a multitude of concerns with creating a shelter on an industrial space. It is particularly noteworthy that the rate payers in the city are adversely affected by city council's decision to not sell the property, and the illegality of placing a shelter on industrial space – both of which have triggered respective lawsuits. Furthermore, the city's own comprehensive plan cites a lack of industrial space, so city council can hardly afford to lose the business and job-creating potential of this space.

I am asking for you to strongly consider rescinding Resolution 37225 on your Nov. 2 agenda.

I am apposed to the use of the surplus city property at Terminal 1 on NW Front Ave. for an impromptu homeless shelter.

The idea for this shelter had no real plan for implementation, with vague references for funding that would eventually have the city responsible for the costs. I feel that it was just a scheme by Homer Williams and Dike Dames to eventually acquire this land to later sell or develop themselves. I'm also aware that housing people on this possibly contaminated site could be unhealthy and dangerous. Their dream of warehousing 100, 500, or 1500 people at their 'Harbor of Hope' will concentrate far too many people in a drafty old warehouse to assure peaceful, safe and secure environment for our most vulnerable dwellers, especially families with children. This method of housing is largely rejected by all of the homeless people I've spoken to. This manner of shelter scares the homeless women I've spoken to about this project. They fear the predatory men that are unfortunately a part of this environment, and seek out the safety of the women's shelters that already exist. The costs incurred by this massive shelter could very well jeopardize these smaller shelters.

I advocate the sale of this property to relieve the surplus property inventory, and encourage it be developed into productive industrial use. It would also relieve the LUBA lawsuit situation, and return needed funds back to the sewerage agency deferring rate increases, as well as not incurring more wasted tax money deviating from a comprehensive plan already established for industrial port accessible uses.

I encourage you investigate the property Tom Cody has graciously donated for use as a temporary shelter location. Although 100 beds seems to be a lot of people concentrated in one area, if the city is determined to find warm, dry and safe temporary housing for those unfortunate to have to live on the streets, I applaud Mr. Cody for his generous gesture. If Homer Williams and Dike Dames would likewise find available locations out of their inventories of properties, and allow them to be used for smaller, more humane shelters, maybe we could make headway against this homelessness problem.

Dear City Commissioners, Mayor Hales and Mayor-Elect Wheeler:

I am writing to offer testimony in favor of rescinding Resolution 37725 in the upcoming Nov. 2 meeting of the City Council.

A temporary shelter transitioning into a Haven for Hope/Harbor of Hope model of care is simply a flawed concept.

It is understandable to enthusiastically explore an idea that seems to promise private and business community investment, to supplement government funds to address the problem, and can show off a large physical plant; yet the fact that they have spent a lot of money and have caring workers does not tell us in any way how well their approach actually works.

Contrary to the self promotional statements coming out of San Antonio and from the advocates for Harbor of Hope, the actual data show the following:

1. The homeless count in San Antonio only dropped by 22% in the 7 years of operation of Haven for Hope. After 7 years and nearly \$200 million dollars. A San Antonio newspaper wrote in Feb. 2016: "No End in Sight for Homeless Camps in San Antonio".

2. They have only housed 4500 individuals in their 7 years of operation, compared to homeless agencies in Portland finding housing for 3500 households in the last year alone.

3. Only about 50% of those they have found housing for remain as "transformational graduates", or "those who have exited to permanent housing and after one year stayed sober and not slipped back into homelessness". Local organizations have a higher and longer term success rate.

4. Harbor of Hope publications are written as if they are creating a new model of care, when in fact they would duplicate investments in infrastructure, skilled staff and the already very comprehensive scope of services present at Central City Concern and other local organizations with decades of experience.

5. A large campus that is designed to shelter, treat, and successfully transition the homeless into a plentiful supply of affordable housing reaches a logjam when it is placed in a tight housing market. This leads to either or both of two difficult consequences: a large campus and transitional housing complex is clogged up with long term residents with nowhere to go, or the very expensive investment in the site and the treatment program is jeopardized when the graduates return to the streets.

6. Terminal 1 is not remotely similar to the site in San Antonio. That site was carefully chosen, with the following considerations cited in its own publications: "The location is a formerly depressed industrial area with a large population of homeless." "The district chosen was largely composed of underutilized and vacant light industrial/ warehouse type facilities. Homeless had already begun to frequent these abandoned buildings." Average home prices in that San Antonio neighborhood are \$50-60,000, with a very large number closest to the site in foreclosure. This contrasts with the community adjacent to Terminal 1, with a very small homeless population and much more than \$1 billion dollars of investment in modern apartments, condominiums, town homes and office space, with Pearl District property values, and preschools and a thriving business community all within just 3-4 blocks of the proposed site.

7. One of their claims to success is unsupported assertions as to fiscal and economic impact, that in reality have a number of crucial weaknesses. Very briefly covering this in one long paragraph: Their analysis pretends that no other programs exist to provide the same types of services. Their tax revenue assumptions ignore that skilled providers are already employed in the field and already paying taxes. The cost savings calculation for the detox program cannot take into account that there already are several detox programs such as the Hooper Center or hospital based programs in Portland. The financial impact is grossly overstated when the long term rate of success is not permanent with indefinite ongoing benefit as claimed, but rather with a high rate of relapse into addiction, poorly controlled mental illness and return to homelessness. The presumed economic impact is actually very difficult to determine, and definitely far less than claimed.

8. The proposal has completely halted home sales in the adjacent neighborhood. There have been no pending or completed sales in the almost 3 months since the Aug. 10 City Council resolution. The scale of this proposed project, a single mega shelter/ treatment facility, has the potential for a disproportionate impact on its surrounding community. The effect on property values and property tax rolls is difficult to estimate, but there would certainly be ample room for decline from current values.

9. Due to the ongoing funding requirements for the Haven for Hope complex, there is a compelling need to sell prospective donors and visitors from other communities on the presumably unique success of the program. But what happens if a few years from now private donors see that it actually costs more and does less...does the center close? Or will the city feel compelled to continue to operate it, " since where will they go?" or "since so much money was spent to build it"?

The Harbor of Hope model is not a good idea for the Terminal 1 site, nor for any other neighborhood. The fundamental issues are insufficient affordable housing, and insufficient funding for the great organizations already doing great work. Their proposal squanders scarce financial and political capital needed to address the problem.

I believe the above information provides ample support to rescind the resolution for this use of the Terminal 1 site.

I know this was a split decision and one that sadly went the wrong way. People watched as some of you bought into this crazy idea that housing 1400 homeless folks in one area in an industrial area that is *crying* to get back to what it was intended for. Then you wanted to put it next to a budding neighborhood with families, children, schools... one that Portland can pride itself on. This is not about not in my backyard, it's about the right thing in my backyard. Small, focussed shelters. These don't rape neighborhoods of their value.

# The list of what has happened over here grows daily thanks to this poor decision timing with the clearing of the Spring Water Corridor. I have tracked it through the entire process and have attached it for you.

Our home sales halted Aug 10, 2016 in fact one of our homes was in escrow for approximately 965K and the buyer pulled Aug 10, 2016 because of your decision. This home still has not sold. Homes were selling like hotcakes over here. We feel the city has stolen our home values, our largest investments, because they threw out a less than well thought out idea to house these people who may not even want to be there, mostly because it's one giant shelter. Even the homeless don't want that.

Trust in the city took a big hit that day. I have championed trying to spread the word on a yes vote for the Affordable Housing measure within our neighborhood and I will tell you... it has been an uphill battle and that is because of the way decisions were made on Aug 10. I personally donated \$1K to this effort because I truly believe in it. You turned a cheek to 10 million dollar offers and played with money that didn't belong to you to use in this way. You offered Homer 10K a month in rent for a property worth SO MUCH more. Then you turn around and ask us for more money for the bond while you stripped us of in some cases hundreds of thousands of dollars in home values. This is a HARD sell!

We all know the only way this problem is ever going to get solved is if you focus on a solution and that is affordable housing. Harbor for Hope is a giant bandaid. It will never work, not in any location. If you push this through, who's home values will you sacrifice next?

Rather than putting 1700 people in a giant shelter I urge you to consider finding 17 locations to house 100 ea. or less and focussed groups i.e.; women, families, pet owners, men only, mentally or drug addicted focus, etc. You can't lump all those people together!

There are some very smart folks over here that live in the T-1 neighborhood. We all want a solution. We want to help find a solution. We feel we can be part of the solution but no one seems to listen to us. It has been very frustrating!

Lastly, This is a HUGE opportunity to for you to do the righting and turn this all around by voting to sell Terminal One & refocus on smaller shelters. All of Portland is watching. All of Portland is voting. All of Portland wants you to do the right thing and I personally would like to gain some trust back in the people who make decisions for all of us in this city that I love.

Don't follow San Antonio... BE a San Antonio and do it better! A realistic plan that includes smaller shelters spread out, absorbed by the entire city with the hope of getting folks back in homes. Be the town other cities want to come visit and see what worked because if the 5 of you put your heads together I know we can be just that.

PLEASE rescind Resolution 37725. Do the right thing.

Thank you! Mair Blatt **7/2014:** Jon Blatt found 4-5 used syringes on what was the dirt area north of Pacifica that is now the construction zone for Rivage. We called the police and their advice was to "go pick them up if we wanted to." (We did.)

**7/15/15:** Chadwick and Ani had a house warming party & one of her guests said there was a man with a knife outside the building (the Waterline). Luckily, no altercation occurred, but my friend was frightened and has not visited since.

**Summer 2015:** Shellie Linscott Lyden's boyfriend Jeff was threatened and chased by a man that was down on the water. Luckily the man didn't see which house he went in. He was very alarmed.

We called the cops last summer about a homeless woman trying to climb over the railing outside our place...would have fallen onto the beach otherwise.

**9/21/15:** Intoxicated homeless man sits on our (1684) stairs, while I'm home, smokes 4-5 cigarettes, flicks them in the bark dust and leaves after about 25-30 minutes. Didn't



move when I left to take my dog out. We had to walk around him.

**2/26/16:** Notice received from TMG about a statue taken from a porch.

6/7/16: Unspecified police activity near Cherri's.

**6/16:** I don't have the date but Jim sees man buck naked taking a bath in the river in front of our houses. :-O

6/16/16: 1st homeless tarp up in bushes near Kirchoff's.



**6/17/17:** For about a week Jim Kirchhoff has words with aggressive homeless youth living in the bushes in front of his place. Police were called

a couple of times. Kirchhoff's were threatened by the young man.

**6/18/16:** Mair sees homeless guy swigging out of a brown bag walking the property.

**6/18/16:** Statue stolen from Kris Salt's porch. Police called by neighbors who stopped him. Statue returned.




**6/21/16:** Homeless man moves back in after being removed by police. Police report filed by Kirchhoff's.

June 2016: Hayley Klug saw a man with a backpack looking in the windows of a neighbors home across the walkway. Debbie Burke Hutchins called the police line and they were not helpful but there is a record of the call.

**6/22/16:** Stranger reported around garages near Cherri's. Later he was asked to leave the property when he was found hanging around garages in the 1680 parking area. Jim Kirchhoff escorted him away.

**6/22/16:** Kacey Baxter (1666) kicked the same homeless man off her steps.



**7/10/16:** From Kacey Baxter: I was pulling out of my driveway to go to work. It was 12:50pm. This crazy guy (mid-50s?) was standing on the sidewalk outside my house at the top of the driveway. I stopped for him to pass and he had something in his hand that looked like a heart shaped rock. He started waiving it at me and muttering something at me. (I wasn't rolling down my window to find out.) He stood in front of my car for a couple seconds continuing the tirade. And then when he passed my car, he turned back and continued. He looked like he was either peddling the rock, selling religion or about to toss it at my car. I am not sure which, but it was sufficiently scary enough to call my baby sitter and tell her to stay inside until he left and lock the doors. (That's how I know what day/time it was.) I can't say whether he was homeless or not, but I can say that he did not fit the neighborhood profile and clearly didn't belong.

**7/12/16:** Mair walks by man with hunting knife early morning while walking her dog on waterfront walkway. He was whittling a stick and looking 'not quite right'. He jumped the fence near Kirchhoff's and went into the bushes. (New homeless tenant?)

**7/30/16:** 3 am doorbell at Lupenhout's. Man with vent mask messed with her pots and when she answered the door he rambled something about the trains and asked if he could come in.

7/31/16: Pincus' find a syringe in their yard.

**Currently:** Garrett Peck mentioned that the camp that is below the Fremont Bridge, below the new apt buildings has grown from one small tent to about 12 significant structures, some of them are quite permanent as I have seen them with battery powered nail guns and 2 by 4's these are not temp. We have witnessed dumping, pooping, pissing and a lot of dis orderly conduct over the last 6 months that gets more common on a daily basis.



Kacey Baxter **took these photos** and says they are entering by using vines to drop down and accessing the south end by entering on the opposite side of the new apartment building. They are tracking footprints along the sand below Riverscape and entering/exiting near Pacifica.

**8/8/16** Peggy Fuller: Someone stole their pug statue from their porch. (2006) Following post: Susan Awbrey Dutra /react-text Sorry. A Buddha & Chinese Foo Dog was also stolen from our front door (2172)






#### 8/11/16 PM

**8/12/16**: Gunderson's hear a woman screaming and sobbing from down below in one of the camps but couldn't see anyone. Picture shows the area she was in.





**8/15/16:** James McGrane took pictures of the access to the camps and pictures of the south camp itself. Included are what we think are stolen bikes.

**8/17/16:** Three boys with skateboards were on the beach below. They climbed up the hillside to 1700's section of Riverscape. One boy really struggled and there was a lot of noise with the climb. Around 9:30 PM a passerby stopped at Howl & Growl and told us a young boy was passed out on the walkway between Riverscape & Pacifica. Jon & Angela checked on him, rolled him on his side and made sure he was OK. An hour later we walked over to check on him, he was still there. His pants were half way down his thighs, underwear exposed. Anna, Jon & I decided to call non emergency for him. At one point he was awake enough to tell Angela he lived in a shelter. The police drove him back to that shelter.

**8/22/16:** Mair found a sleeping bag in the bushes near Kirchhoff's. Jim placed it in a plastic bag and set it out with the trash on the curb.



**8/22/16:** Gail Pincus told mair that her tenant in 1692 smelled smoke and found a plant fire outside her window directly against her condo. She poured water on it. Apparently it was caused by a tossed cigarette. Jim Kirchhoff said this has happened on their side (Riverfront) as well. Mair noted the discarded cigarettes at the bench at 1690 and will talk to Waterline to send a reminder to their





homeowners who come here to smoke.

**8/27/16:** Noted, homeless man with a full shopping cart headed our way down Front at NW 17th. Not sure of his end destination but noting it as the Spring Water sweep is on 9/1/16.

8/28/16: 1692 NW Riverscape St had another fire in the same bush. This time the fire



dept came and put it out. Mair spoke to the Waterline apartment managers again.



8/29/16: air spotted yet another cigarette at the charred bush and asked the neighborhood to be vigilant in watching for this person throwing cigarettes in the bushes. Linda Gunderson also said she found burnt matches at the walkway at 17th street. **9/4/16:** Woman in large army coat scouting possible campsite. I saw her 3 times looking at the land by Krichhoff's.

**9/4/16:** Jim Kirchhoff cut a large amount of blackberry bush branches and threw them in the hole. It is not pretty uninhabitable.


**9/5/16:** Another looker, this time a man on a bike. Jim & Mair created a fake camp to make this area look "lived in".

#### 9/8/16:

FYI- someone pooped on my stoop... Human feces, not dog... and on my welcome mat. - Stacie Taylor 2010 NW 16th.

#### 9/11/16

Neighborhood beach clean up on the beach below. 12 Hefty bags of garbage and a tire along with about 12 used syringes were picked up.



#### 9/12/16

Amy & Carlos reported an illegal campfire in the camp below FORE. They called it in.

**9/13/16** Nicholas Moen reports at 11:32 pm: Took my dog out and saw this person sleeping outside the Waterline office and 3 people sleeping in this car. Also, jackets and clothes where a guy was waiting for me to go inside so he could find a place to sleep in between the buildings.



9/16/16 Kris Salt posts about 3 guys hanging out down below on the beach.



9/18/16 Brian Currier reported an illegal campfire down below on the beach.



**9/19/16:** Deb Elsenhout reported new graffiti (A mural) on the beach below.

**9/22/16:** Mair photographed a woman in the neighborhood with a shopping cart. She looked a little strung out. She did not stay here, she seemed to be passing thru.



**9/21/16:** Jim Kirchhoff has words with a homeless man sitting on our private property just hanging out. More details to come. We believe this man lives at the FORE camp and he has been seen with 2 others loitering on the beach. He wasn't harming anything but was simply trespassing which is not allowed here.

**9/22/16:** From Melissa Jaffe at Waterline: You may want to note the small camp that has developed along the train tracks, behind the warehouses along front street. As you go down 17th away from the river, look to the right. I've seen it grow, right by the graffiti.

9/22/16: Kris Salt reports that the FORE campers are cutting away at the



vegetation to use as firewood. It was reported to the Willamette Riverkeepers.

**9/22/16:** Stacie Spencer Taylor reports: My friend visiting from Seattle had her **car broke into** last night (9/21/16) on Front street...be sure and keep your personal belongings out of sight. They stole her chiropractic table and a bag that was beneath... not a small item to make off with:

9/23/16: Fire department called and responded

to a fire down at the Fore Construction camp. Fire department extinguished. It was suggested that the ladder to the camp be pulled to make access more difficult.

**9/25/13: Car broken into** a block from us, NW 17th between Upshur & Thurman. The car in front of this was broken into but this car had already left. The glass was all that remained behind.




9/27/16: Neighbor reported Homeless gal with shopping cart next to FORE Development working her way to the camp below.



10/1/16: Mari Schwartz reported via NW Neighborhood Rooster:

A one-year-old 26" Schwinn Sidewinder Women's Mountain Bike, Matte Black/ Pink was stolen between the afternoon of 10/1/2016 and early morning of 10/2/2016 from the front porch of my condo on Riverscape condo complex. My condo is right on the Willamette and is facing the public walkway. The bike was secured with a lock to the fencing. The lock was left undamaged, so I think it was a professional job.

10/4/16 Kris Salt reported a new camp and a possible stolen bike operation.





10/8/16: New camper has another new bike and a cart.



**10/8/16:** Police were called after reports of multiple 'new items' were seen down at the new camp below FORE construction site. **One man arrested** for possibly stolen credit cards and drugs. No update on the stolen merchandise. Concerned neighbors watched from above.

**10/10/16: Ladder had been removed** last weekend after police came but it is now back and an estimated 30-40 people live there currently. **It is a small tent city.** 

**10/12/16:** Jon Blatt reports: The one tent on the corner nearest to us has about 10-15 bikes, wheels, etc. The pit bull is still here with a blond woman.





10/13/16: New bikes at the camp.

10/13/16: Camps are growing across the river. Rain





**10/13/16:** Kacey Baxter reports her Ring Video doorbell captured a man she believed was possibly peeing on her porch

**10/13/16:** Excerpts from the responding officers letter in response to our call about campers:

Brian,

I was the officer in yellow who responded to the encampment last Saturday. 'I was the primary officer in charge, but the other officers that assisted in the investigation were Ofc. Quinsland, Ofc. Payton, and Ofc. Mac Nabb. Thank you for letting us know about this area. I personally had no idea that it existed before this. The case number on this is 16-326363. The bad guy that we arrested was in possession of a stolen bike as well as a very large quantity of methamphetamine. His name is Carlos Alberto Figueroa-Lopez Age 46. He also had a federal felony warrant. He was on federal probation for possessing a handgun while dealing drugs. I charged him with possession of the stolen bike, delivery of meth, possession of meth, and his warrant. He will likely be sent back to prison, so hopefully this alleviates some of the issues down there that are most certainly fueled by drug use/ dealing.

Let me know if you have any questions or ongoing concerns. Also, we are forwarding information to a sergeant in charge of these livability issues. Hopefully his team can put it on their radar and assist in the removal of this shocking encampment. I can't believe how entrenched this has become! I've never seen anything like it.

10/16/16: New bike at the chop shop below.




**10/16/16:** Art floating in the river from one of the camps. As the water rises, ALL of that crap will be in the river.

**10/17/16:** Fire Department called for open fire on the



beach. Smoke coming into homeowners windows. \*\*We don't call because we smell a little smoke, it is often overwhelming and has a chemical smell. It is aggravating several homeowners with Asthma as well.

**10/17/16:** Jonie spotted this **man peering into her windows** on her way home. She observed him then look into the windows of two neighbors here at Shoreline and then move on to Waterline windows. She believed he was very high and watched him remove his sweatshirt and put it back on over and over. His pants were falling down. She called 911, they told her to stop following him for her safety and they responded to the call. A renter at Waterline witnessed this as well.



**10/18/16:** Jonie reports this same man at the fence on 10/18/16 was peering into Scott's windows. She ran him off.

**10/18/16:** Marjana Gratteri posted: Just called 911 about the fires this morning as it's very strong inside again. I was told they will be coming out but if it's clean wood there is nothing that can be done (doubt they will actually check and those palates are typically treated). The operator did suggest calling DEQ which I will look into now...

**10/18/16:** Deb posted she has watched 3 of the folks below try to relocate on the property because of rising rivers.



**10/18/16:** Marjanna reports: Spoke with great guy at DEQ and they cannot do a thing. His words were: "they can only enforce tax paying, home owning, working people". Suggested to just keep sending complaints to Mayor's Office because this all is very low priority. 10/19/16: Underwear on the steps of 1688.



**10/18/16** (approx.) You may see plywood at Safeway where 2 panes of glass on the sliding glass doors are. Not our immediate vicinity but our neighborhood blocks away store none the less. I was told that a man at 1:30 am came to buy beer moments after the store closed and they wouldn't re-open for him so he threw 2 bricks thru the window.

**10/10/16: Several police/homeland security** SUVs in the neighborhood reported... so far I counted 3. Curious if this related to that drug deal witnessed recently. K-9 unit as well.

10/20/16: Person going #2 in the bushes.





**10/20/16:** Deb shared a pic of some boots and Angela reported that she saw the owner of the boots on Riverscape near 17th. The 'worn' woman was stopped talking to a man in a blue minivan. Ang overheard him ask if she was from Craigslist. They saw Ang and separated. As Angela walked away they hooked up again, she got in his car and she left the boots behind. In the same area condoms have been found by another homeowner. Please keep an eye out for 'tricks' being turned on our street and if you can safely get a pic please do. This was pretty obvious to Angela what was going down.



**10/20/16:** Jacob Jacobson reports: Just picked up two full sets of men's and women's clothes left on my corner neighbors front steps. And I mean full sets from socks to undergarments. (Belonging to a homeless person.)

**10/20/16:** Brian Lynch posted: Just saw two questionable characters knock on 1722 and then 1720, saw me watching and left.

**10/22/16:** Tom Landers posted: Just came across another "transaction" with a young girl, this time in the west coast productions parking lot. Called non-emergency. Operator said that if I saw it and they were still there, I should call 911, because they take that very seriously.

**10/23/16:** Jonie reported she witnessed a young girl shooting up.



10/25/16: City announces T-1 will not happen.


**10/26/16:** Michaela Bancud reported that this **gold van** is associated with the camp down below.

Dear Mayor Hales & City Commissioners:

I'm writing to encourage you to rescind resolution 37225 and open up Terminal 1 for sale. Since the August decision, many things have changed. The city did not see an effective and sustainable plan to support Harbor for Hope. And Tom Cody has generously donated property to support many in our vulnerable population this winter. Feels like we are making steps toward viable solutions.

**LEGAL:** It is unknown how this property would be impacted by existing lawsuits. We've seen wasted funds with R2D2 tied to similar LUBA suits. To withhold sale of Terminal 1, with pending legal action would be irresponsible for our city & taxpayers.

**RATEPAYERS**: Sale would provide ratepayers with \$10-\$12M of immediate relief. This is the responsible action for our community.

**ECONOMIC:** Terminal 1 is a prime piece of property, set aside within an industrial zone. The sale of this land could create high paying, industrial jobs, generating corporate tax revenue for the city. As our city continues to grow, its critical we are creating jobs for our community. The tax revenue opportunity appears significant.

I encourage you to please allow for bids and the sale of Terminal 1.
