ORDINANCE No. 188081

Authorize an agreement with Oregon Sports Authority for national and international sports marketing activities and event recruiting services and provide for payment (Ordinance)

The City of Portland ordains:

Section 1. The Council Finds:

- 1. Oregon Sports Authority (OSA), a non-profit organization, is uniquely positioned to conduct the services of securing sports events, sports conventions, and facilitating sports franchise acquisitions for the City of Portland. OSA has spent more than 20 years building relationships and trust with a broad range of sports organizations including Major League Soccer, Major League Baseball, Davis Cup, Dew Tour, and the NCAA.
- 2. Over the last two decades OSA's marketing and recruiting efforts have contributed more than \$200 million dollars of economic activity from sports events and sport tourism in the state a majority of which has been within the City of Portland.
- 3. The City benefits financially in a range of ways from major sports events and their attendant tourism activities, including increased user fee revenue for events at the Moda Center, Veterans Memorial Coliseum, and Providence Park and increased transient lodging tax revenues from out of town travel associated with events in the region.
- 4. The Spectator Venues & Visitor Activities Fund Statement was updated with the FY15-16 Budget to specifically include the support of City travel, tourism, and visitor development efforts such as the work undertaken by OSA.
- 5. The City has financially supported OSA's efforts as a dues paying member of the organization for almost 10 years. A multi-year contract will enhance OSA's capacity and provide more opportunity for the City to shape and support the organization's goals and to increase the City's economic benefits from OSA's work.
- 6. Funding for this agreement was included in the requested FY16-17 Spectator Venues & Visitor Activities Program Budget.

NOW THEREFORE, the Council directs:

- a) The Mayor is hereby authorized to execute an Agreement with Oregon Sports Authority substantially in accordance with Exhibit A attached to this Ordinance.
- b) The Mayor and Auditor are authorized to draw and deliver checks chargeable to the Spectator Venues & Visitor Activities Fund when demand is presented and approved by the proper authorities.
