ORDINANCE NO. 188083

Authorize a contract with the lowest responsible bidder and provide payment for the construction of the SW Vista Avenue Water Main Improvement Project at an estimated cost of \$533,000 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The existing 1,042 feet of 8-inch water main located in SW Vista Avenue was installed in 1927. The water main has had six leaks with four occurring in the last two years and the Water Bureau's Maintenance and Construction staff recommend replacement.
- 2. The Water Bureau requires construction services to construct a replacement for the water main.
- 3. The construction work includes installation of 1,083 feet of 8-inch main, 635 feet of 6-inch main, 3 hydrants, renew 21 1-inch services, renew one 2-inch fire service, install one 6-inch by 2-inch regulator and vault, and abandon 1,042 feet of 8-inch main.
- 4. The engineer's estimate cost for the contract action is \$533,000 with a high confidence level. Funding for this project is available in the FY 2016-17 budget and will be requested in the FY 2017-18 budget.

NOW, THEREFORE, the Council directs:

- a. Upon the Council's acceptance of the Chief Procurement Officer's report recommending the lowest responsible bidder, the Chief Procurement Officer is authorized to negotiate and execute a contract, provided the contract has been approved as to form by the City Attorney's office.
- b. The Mayor and Auditor are hereby authorized to draw and deliver checks chargeable to the Water Fund when demand is presented and approved by the proper authorities.
