

**RESOLUTION No. 37249**

Appoint Andrea Chiller to the Citizen Review Committee advisory board to the Independent Police Review, a division of the City Auditor's Office. (Resolution)

WHEREAS, the City Council adopted Ordinance 175652, June 6, 2001, establishing the Independent Police Review and the Citizen Review Committee;

WHEREAS, an eleven-member Citizen Review Committee is responsible for ensuring impartial hearings of appeals, participating in public outreach efforts, and providing an advisory role to the Independent Police Review;

WHEREAS, the committee has one vacancy resulting from the resignation of one member;

WHEREAS, a Selection Committee consisting of three Citizen Review Committee representatives, two members of the community, and the Assistant Program Manager of the Independent Police Review recommended applicants to hold in reserve to fill vacancies in the event of a resignation;

WHEREAS, the City Auditor nominated one recommended member to City Council;

NOW, THEREFORE, BE IT RESOLVED, that the City Council for the City of Portland, Oregon appoints to the Citizen Review Committee new member Andrea Chiller for a three-year term that will begin November 23, 2016 and end November 25, 2019.
