Declare support for Tim Raines's induction into the Baseball Hall of Fame in 2017 (Resolution)

WHEREAS, Tim Raines is ranked 108th of all time in the critical sabermetric category of "wins above replacement" (WAR), higher than over 100 player-members of the Hall of Fame, which includes 217 former major leaguers; and

WHEREAS, Tim Raines has a higher WAR ranking than 13 of the 17 left fielders in the Hall of Fame; and

WHEREAS, Tim Raines ranks 54th of all time in runs scored, with 1,571; and

WHEREAS, Tim Raines ranks fifth of all time in stolen bases, with 808; and


WHEREAS, the 2017 Hall of Fame ballot is the tenth and last on which Tim Raines will appear.
