

ORDINANCE NO. **149001**

An Ordinance transferring one City Planner III from the Bureau of Planning to the Housing and Community Development Appropriation Unit; creating one City Planner II at the established compensation rate within the Housing and Community Development Appropriation Unit; returning \$22,412 to HCD contingency and General Fund Unforeseen Reimbursables; transferring a total appropriation of \$66,912 within the Housing and Community Development fund; approving an effort by the Housing and Community Development Appropriation Unit to identify projects and prepare applications for Urban Development Action Grants; and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The City of Portland is eligible to apply for Urban Development Action Grant funds under criteria established by the Department of Housing and Urban Development.
2. Urban Development Action Grants represent a significant and flexible resource for specific projects relating to community and economic development.
3. The City of Portland desires to identify potential projects and to prepare applications for Urban Development Action Grant funds in accordance with federal regulations and standards for the program in order to implement City objectives and policies for community and economic development.
4. The costs of such an effort are eligible activities under HUD regulations for the Housing and Community Development Block Grant program (24 CFR 570.205).
5. The Office of Planning and Development has determined the appropriation requirements for such an effort and has identified resources within the HCD Fund and the General Fund which are available for such an effort.
6. The Office of Planning and Development has determined that necessary staffing requirements can be met by transferring one City Planner III from the Bureau of Planning to the Housing and Community Development Appropriation Unit and by creating one additional position of City Planner II within the Housing and Community Development Appropriation Unit.

NOW, THEREFORE, the Council directs:

- a. The initiation of efforts by the Office of Planning and Development to identify potential projects and to prepare applications for Urban Development Action Grants.
