The City of Portland ordains:

Section 1. The Council finds:

- 1. Work under this contract includes commissioning services, fundamental and enhanced, on a requirements basis for The Portland Building Reconstruction project.
- 2. The services were advertised under RFP No. 00000412 and eight responsive responses were received. The selection committee reviewed and scored the proposals in accordance with PCC 5.68 and selected Interface Engineering.
- 3. The City desires to enter into a PTE contract with Interface Engineering, attached substantially in conformance with Attachment No. 1, with a not-to-exceed contract amount of \$198,720.
- 4. The M/W/ESB participation in this contract is 21%.
- 5. Funding sufficient to cover this contract is currently appropriated in the Facilities Services Fund.

NOW THEREFORE, the Council Directs:

- a. The Chief Procurement Officer is authorized to enter into contract No. 30005569 with Interface Engineering in an amount not to exceed \$198,720 and in a form substantially in conformance with Attachment No. 1.
- b. The Chief Procurement Officer and the Auditor are hereby authorized to draw and deliver checks payable to Interface Engineering when demand is presented and approved by the proper authorities.

Section 2. The Council declares that an emergency exists to prevent burdensome and costly project delays. Therefore, this Ordinance shall be in full force and effect from and after its passage by Council.
