ORDINANCE No. 188107

Authorize the Bureau of Environmental Services to execute an easement with TriMet as part of the Portland to Milwaukie Light Rail: SE Powell Boulevard/16th Avenue Storm Sewer Project No. E10060. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Bureau of Environmental Services (BES) needs to acquire a sewer easement from Tri-County Metropolitan Transportation District of Oregon (TriMet) for the ongoing operations and maintenance of the sewer facilities constructed under the Portland to Milwaukie Light Rail: SE Powell Boulevard/16th Avenue Storm Sewer Project.
- 2. BES has designed and constructed the Portland to Milwaukie Light Rail: SE Powell Boulevard/16th Avenue Storm Sewer Project to repair and replace several sewer lines and other related facilities prior to the start of construction of the Portland to Milwaukie Light Rail Project.
- 3. TriMet requires that the City indemnify them for use of the permanent easement area for any damage caused by the City or its representatives as described in Exhibit 1.
- 4. The cost of the easement is one dollar and funds are available in the Sewer System Operating Fund, FY 2016-2017 CIP BES Project E10060, Account No. 563300 (permanent asset). BES's level of confidence in the cost estimates for this project is optimal.

NOW, THEREFORE, the Council directs:

- a. The Commissioner-in-Charge is authorized to execute an easement substantially in the form of the attached Exhibit 1 with TriMet, for the purposes described in Section 1.
- b. The Mayor and City Auditor are hereby authorized to pay for the easement from the Sewer System Operating Fund Budget.
