ORDINANCE NO. 188113

Authorize a contract and provide payment for the construction of the Sandy River Engineered Log Jam Placement Project at an estimated cost of \$2,300,000 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Water Bureau requires a contract for the construction of the Sandy River Engineered Log Jam Placement Project (Project) as described in the Water Bureau's Bull Run Water Supply Habitat Conservation Plan (HCP).
- The Water Bureau's HCP, approved by City Council on October 1, 2008 through Ordinance No. 182235, commits the Water Bureau to place engineered log jams at strategic locations in the lower Sandy River Basin. Implementation of the HCP projects allows the City to be in full compliance with the federal Endangered Species Act and Clean Water Act.
- 3. Ordinance No. 187573 authorized the use of the cooperative procurement method to enter into a Professional, Technical, and Expert contract with Wolf Water Resources, Inc. for the design, engineering, and construction management of the Project.
- 4. The Water Bureau requires a construction contract to execute the Project, which will restore habitat for native fish, as described in the HCP.
- 5. The engineer's estimate for the contract action is approximately \$2,300,000 with a low confidence level. Funding for contract work is available in FY 2016-17 budget and will be requested in the FY 2017-18 budget. The Project is scheduled to be completed during FY 2017-18.

NOW, THEREFORE, the Council directs:

- a. Upon the Council's acceptance of the Chief Procurement Officer's report recommending the lowest responsible bidder, the Chief Procurement Officer is authorized to negotiate and execute a contract, provided the contract has been approved as to form by the City Attorney's office.
- b. The Mayor and Auditor are hereby authorized to draw and deliver checks chargeable to the Water Fund when demand is presented and approved by the proper authorities.


