ORDINANCE No. 188115

*Authorize a Special Appropriation grant agreement with Miracle Theatre Group DBA Milagro in an amount not to exceed \$50,000 for construction costs for Milagro's public space facilities improvements (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Milagro is an arts organization on Portland's eastside, serving as a hub for diverse cultural engagement and community activities in Portland's Latino community and other cultural groups.
- 2. Milagro's facilities improvements will make the community convening space, El Zócalo, more accessible and functional for the many community groups that use them.
- 3. Milagro submitted a grant application for the FY2016-17 special appropriations grants competitive process and was selected as one of the twenty to be awarded a grant.
- 4. Milagro's mission is consistent with Council's desire for equity and inclusion.
- 5. In accordance with the FY2016-17 Budget, the City now desires to make a grant to Milagro in an amount not to exceed \$50,000.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to enter into a grant agreement, as outlined in a form substantially in accordance with the agreement attached as Exhibit A, at a cost not to exceed \$50,000.
- b. The Mayor and Auditor are hereby authorized to draw and deliver payment chargeable to the Fiscal Year 2016-17 Budget

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the grantee's ability to perform the activities authorized by the grant. Therefore this ordinance shall be in full force and effect from and after its passage by the Council.
