

ORDINANCE No. 188120

*Pay claim of Thai Gurule, in the sum of \$90,000 involving the Portland Police Bureau.
(Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Thai Gurule, through attorney Stephen Houze, has filed a claim for damages against the City for injuries suffered when he was arrested in an incident occurring on September 14, 2014.
2. The claim has been investigated by Risk Management Services and the City Attorney's Office. The investigation indicates there is risk the City may be found liable. Therefore, in order to avoid the risk of an adverse jury award, we feel it is prudent to compromise the claim at this time.
3. Risk Management Services and the City Attorney's Office recommend the claim be compromised for the total sum of \$90,000.00, subject to the claimant providing the City with a release in a form to be approved by the City Attorney.

NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver two checks in the following amounts:
 1. one in the amount of \$57,979.34 to Pacific Life & Annuity Services Inc, and
 2. one in the amount of \$32,020.66 payable to Stephen A. Houze.
- b. Risk Management Services will execute a payment authorization in the amount set forth in sub-paragraph (a) above.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this claim; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.


