L1: MLK/Grand Corridor, south of SE Clay



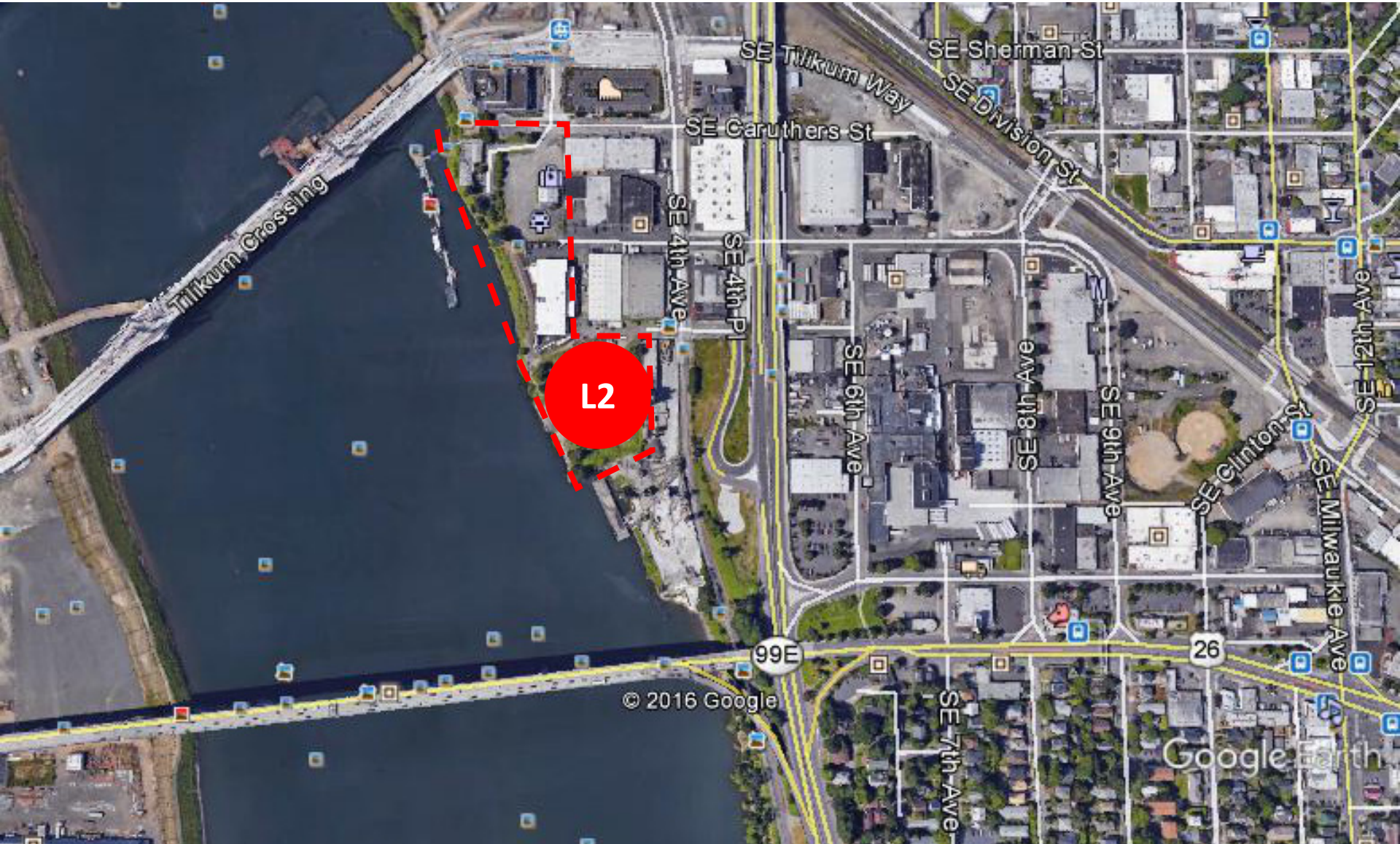

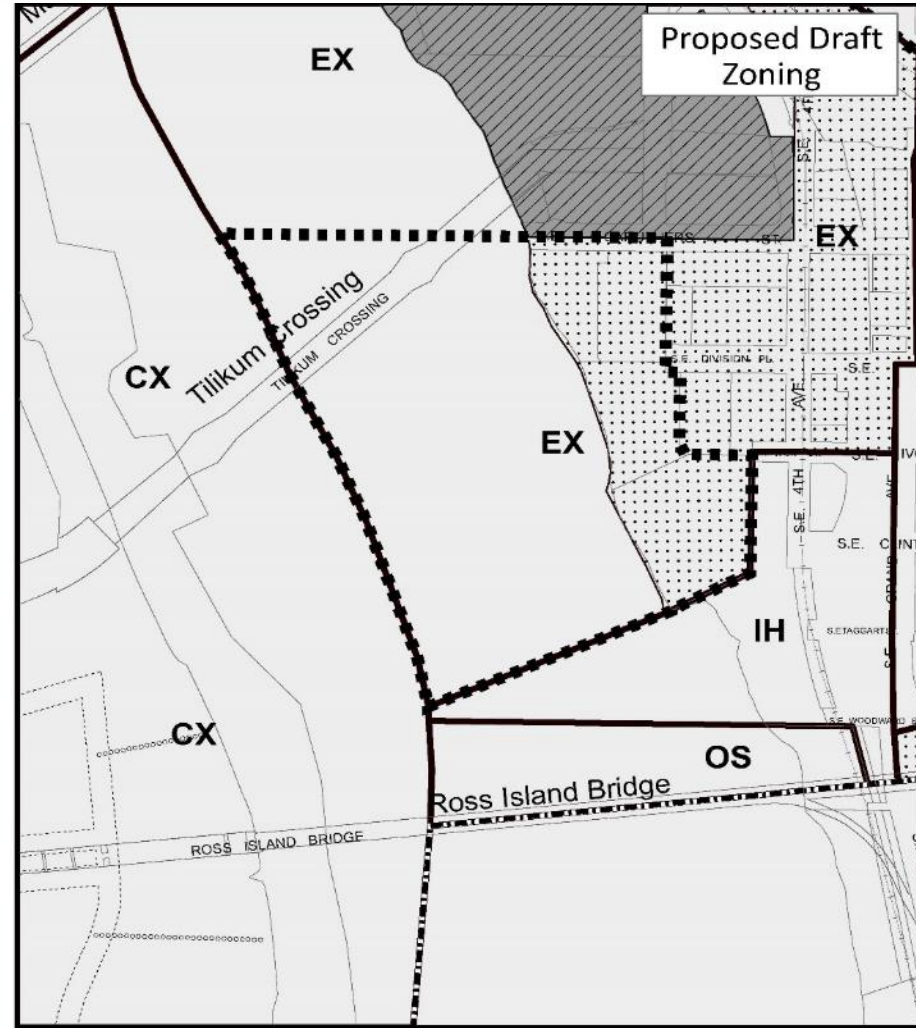
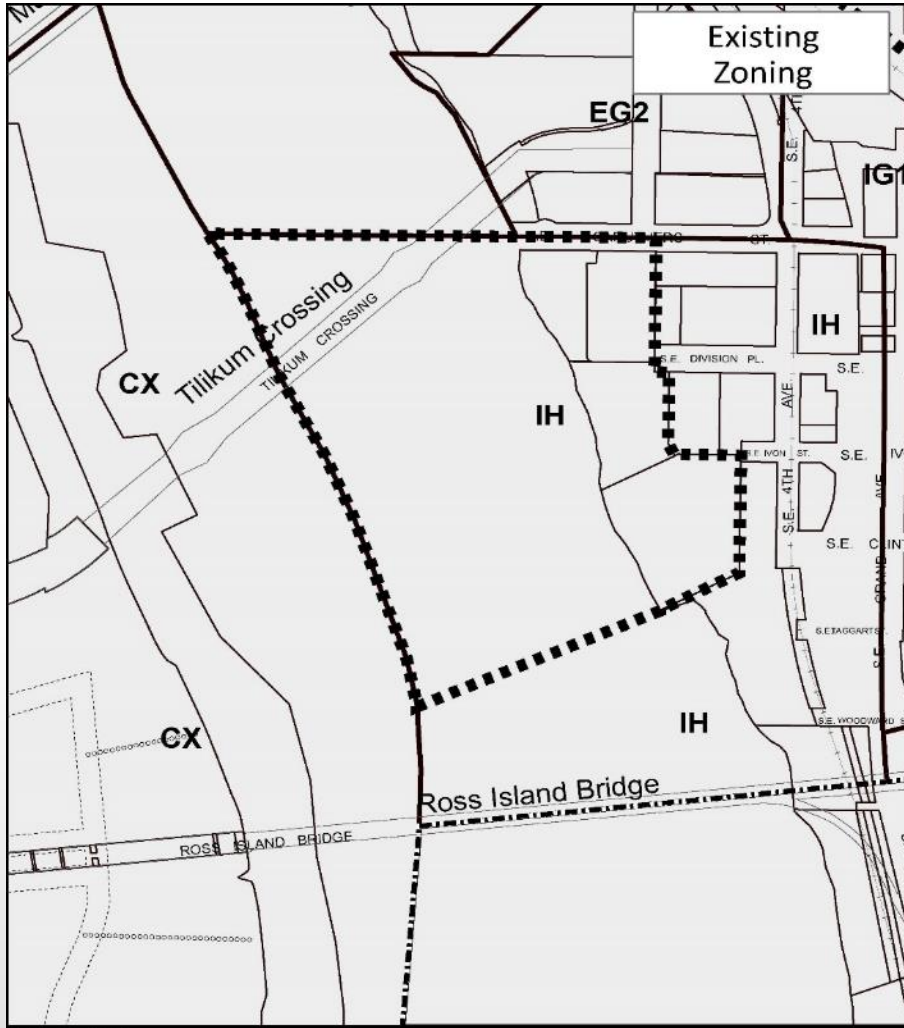

L2: Area South of OMSI Station Area

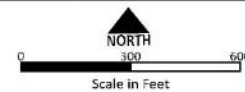

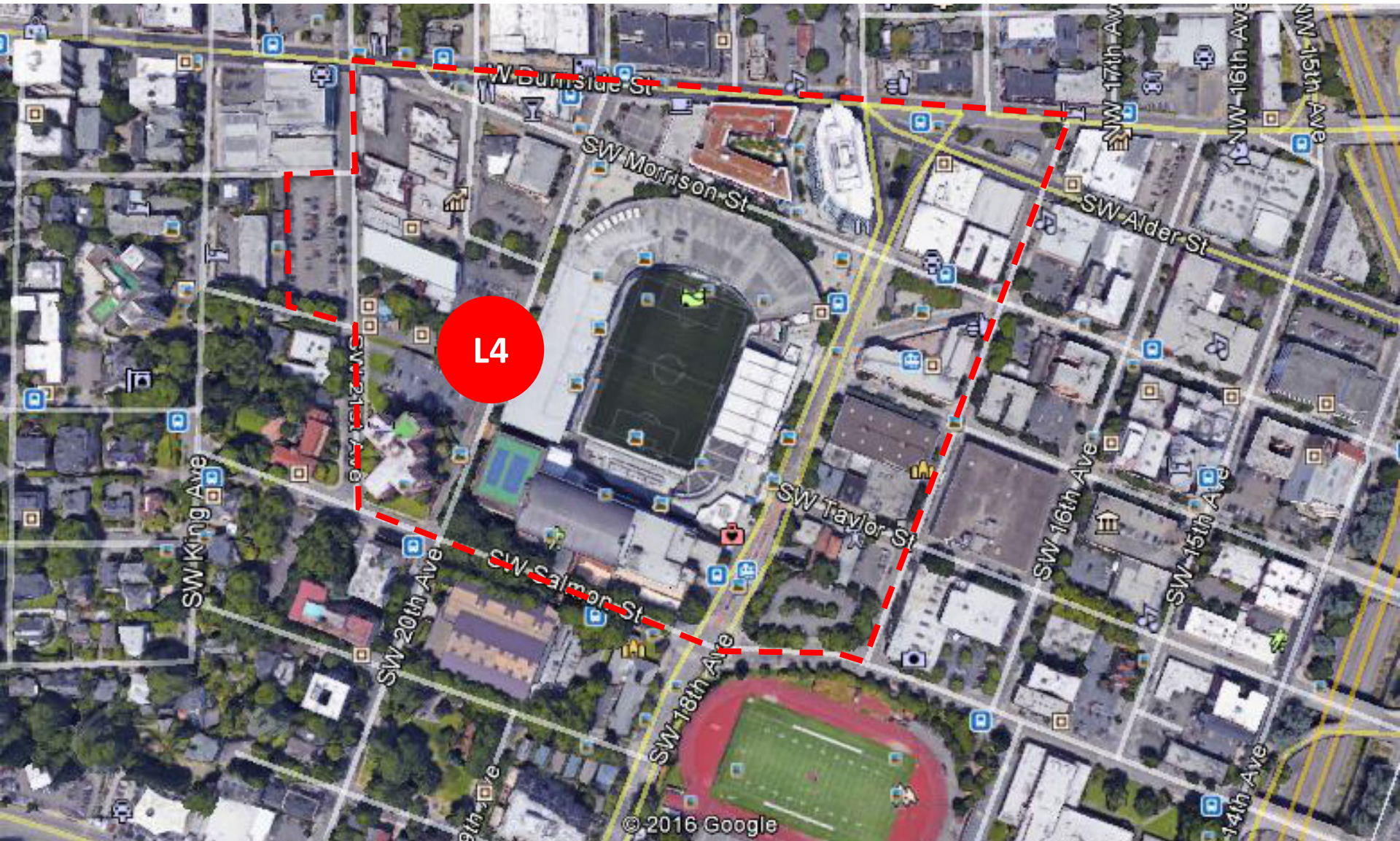
L3: Half blocks east of South Park Blocks



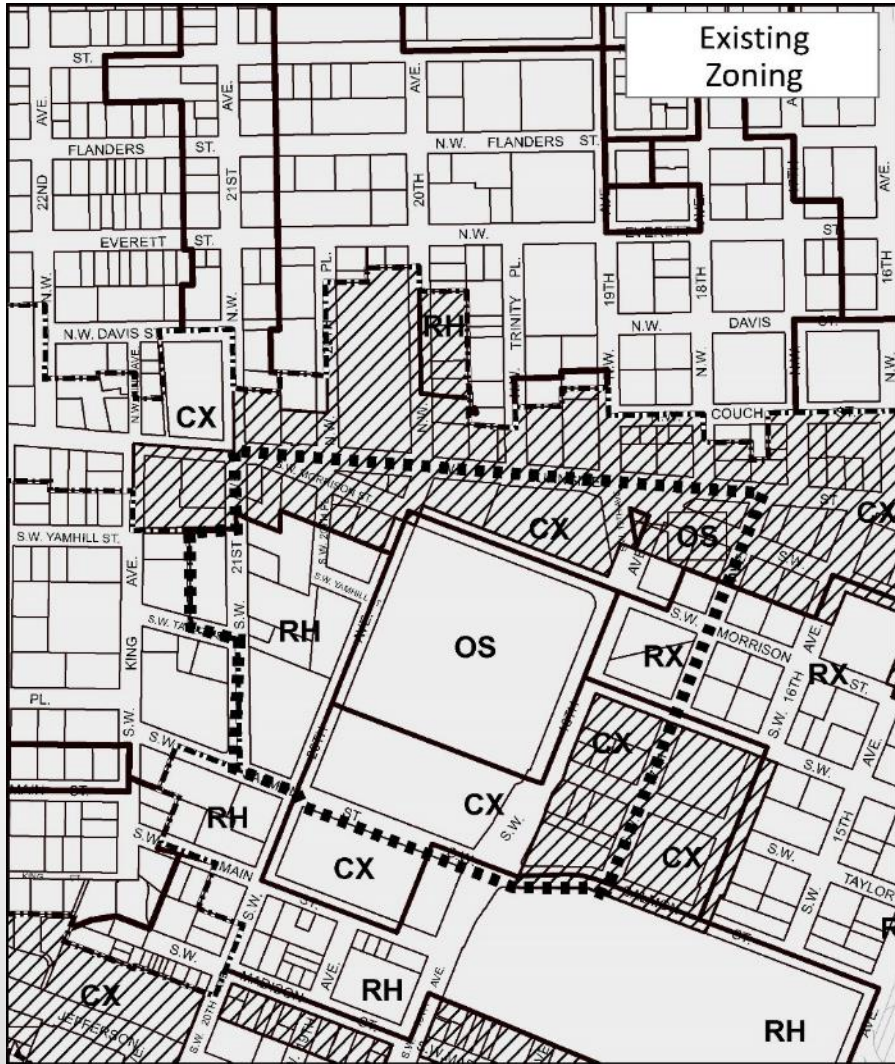

L4: Blocks east and west of Providence Park

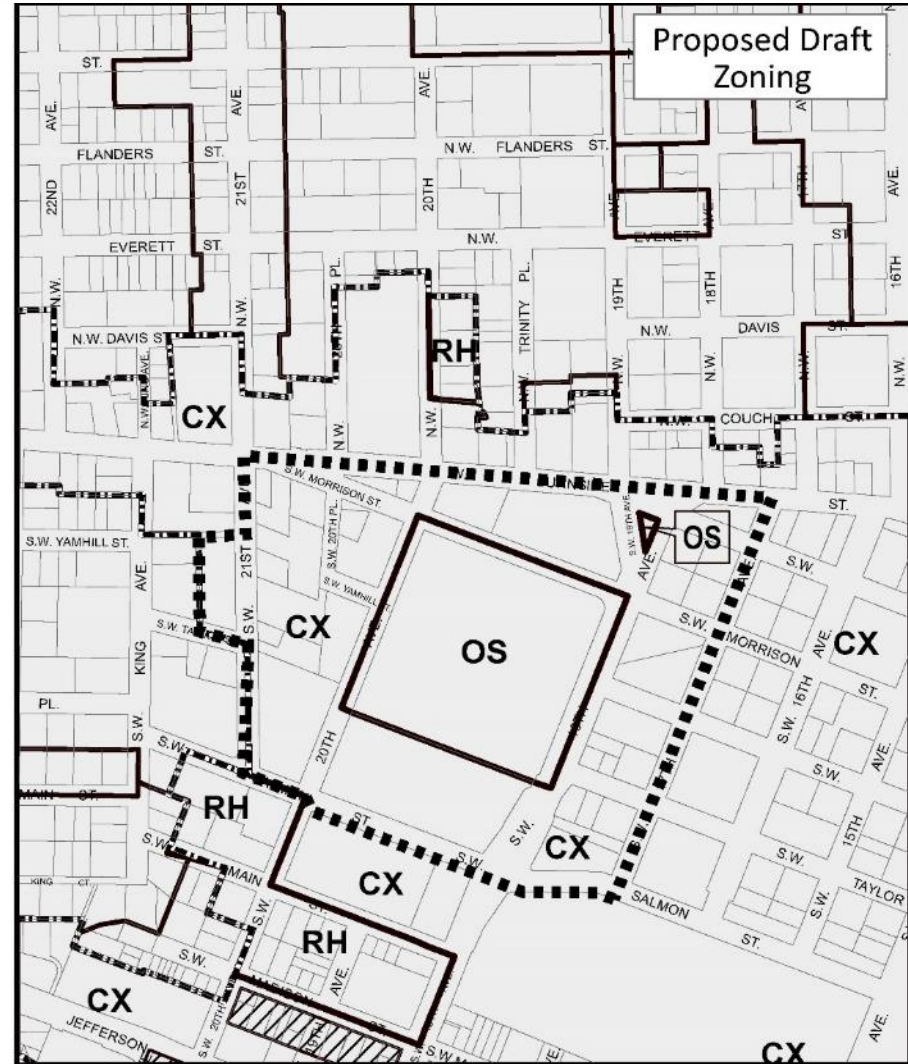

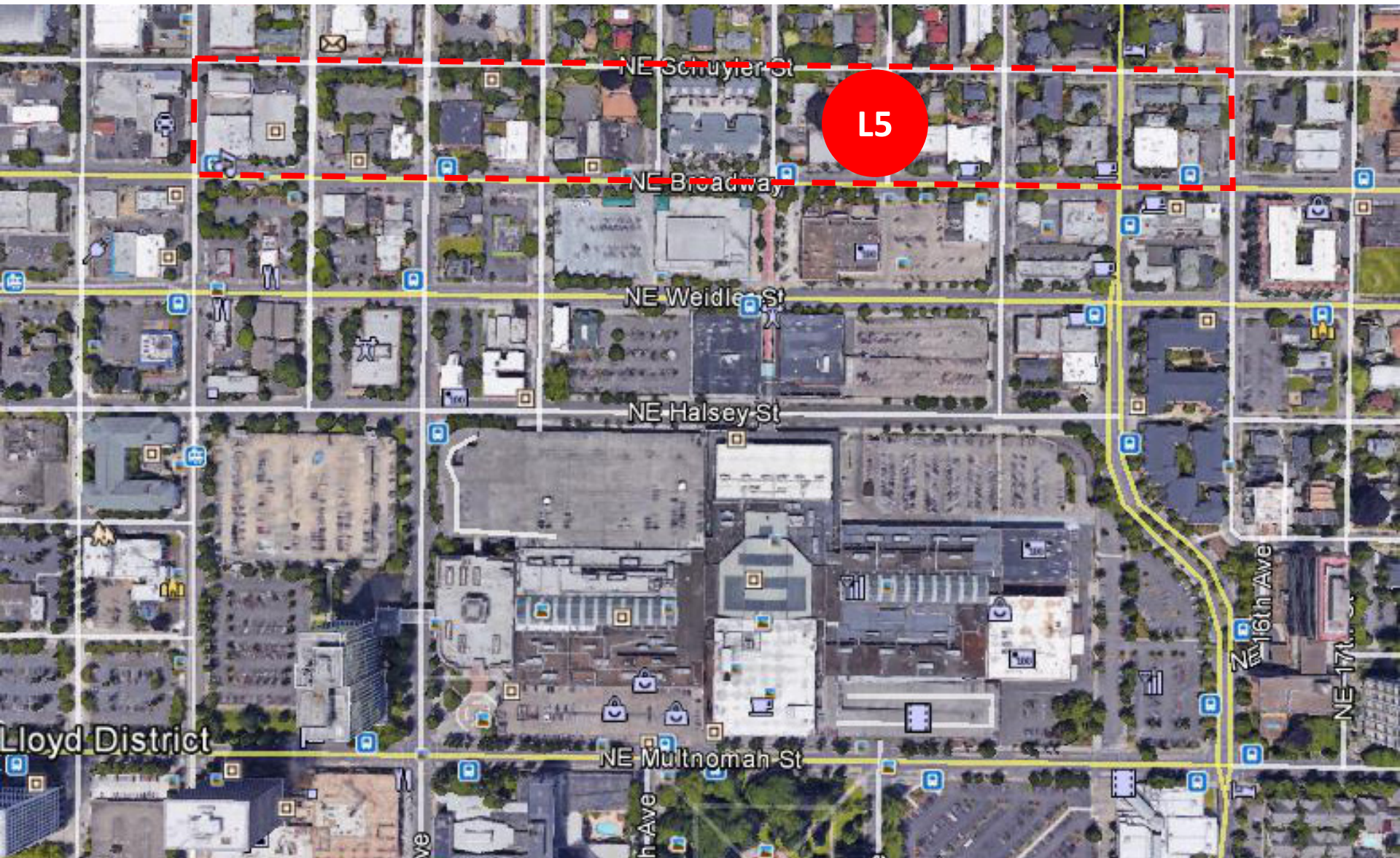

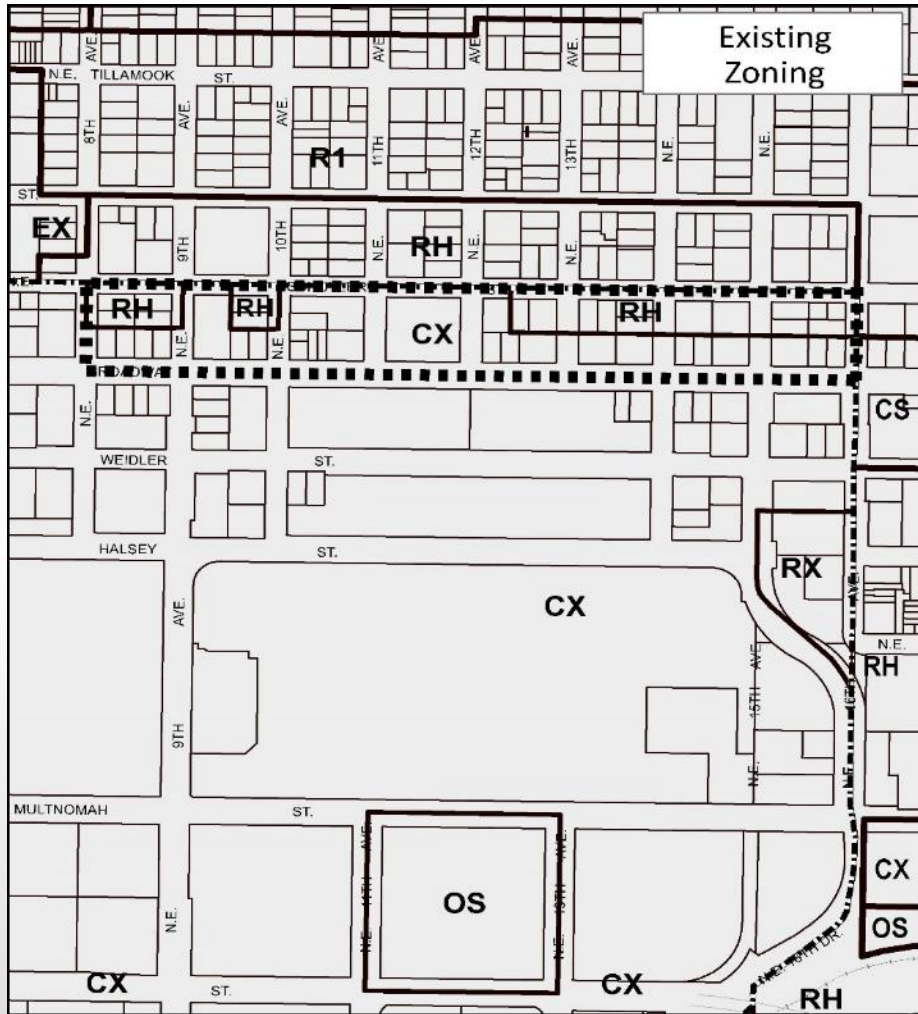

L5: Edge between Lloyd District and Irvington

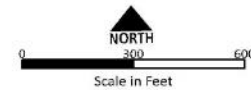
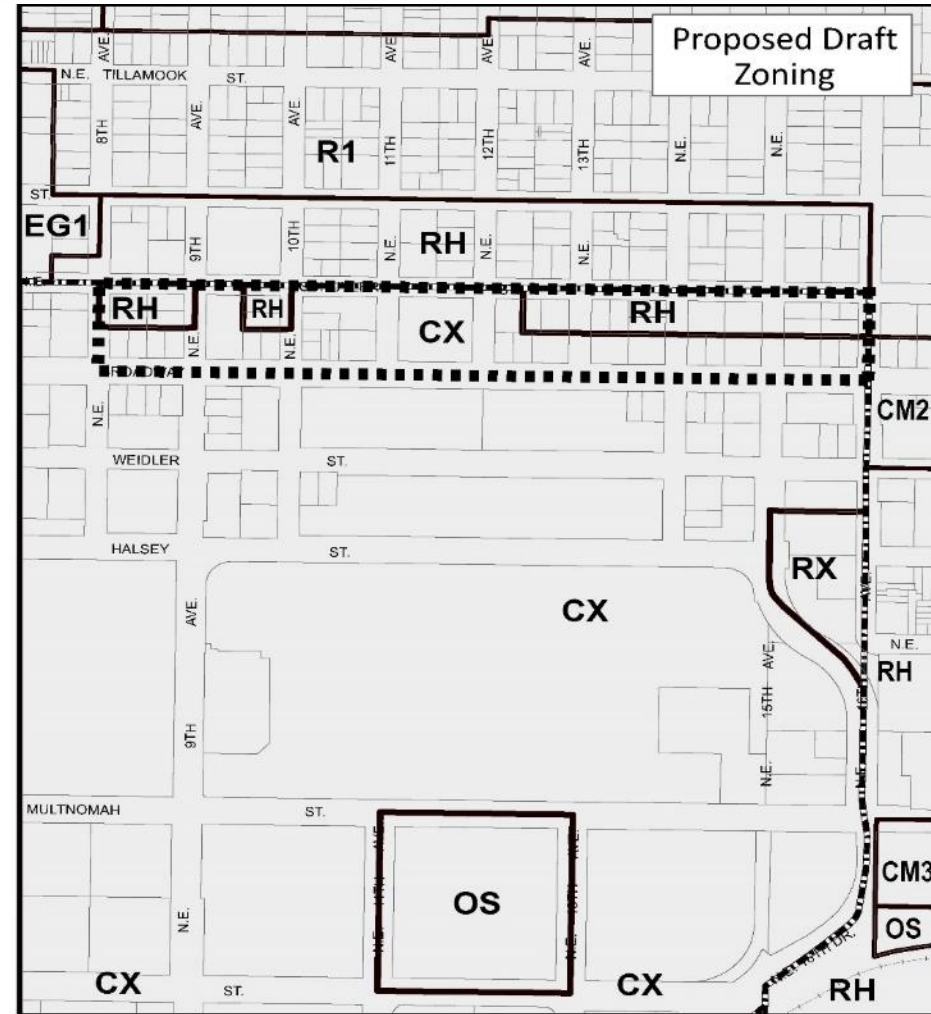

L6: Parcel near NE Mississippi MAX Station in Lower Albina

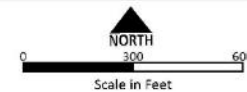

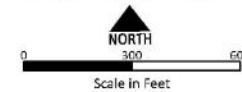
L7: Northern section of West End District
