ORDINANCE No. 188154

* Amend FY 2016-17 Fall Supplemental Budget ordinance to correct for technical errors (Ordinance; amend Ordinance No. 188061)

The City of Portland Ordains:

Section 1. The Council finds:

- 1. On October 26, 2016, Council passed Ordinance 188061 approving the FY 2016-17 Fall Supplemental Budget and other budget-related changes.
- 2. Ordinance 188061 amended the FY 2016-17 Appropriation Schedule, changed the number of authorized positions in the FY 2016-17 Revised Budget, authorized changes to the overhead model cost pools, and adjusted the Current Appropriation Level target for the Portland Housing Bureau.
- 3. Ordinance 188061 directed the City Budget Office to adjust the Current Appropriation Level target for the Portland Housing Bureau in FY 2016-17; however, the intended first year of the adjustment was FY 2017-18.
- 4. Ordinance 188061 stated in Section 2 that "The Council declares that an emergency exists in order that FY 2015-16 Fall budget adjustments are implemented without delay...", however, the correct year of the budget adjustments is FY 2016-17.
- 5. Ordinance 188061 contained five exhibits with information that remains unchanged and attached to this ordinance. This includes the correct year of the required Current Appropriation Level target adjustment for the Portland Housing Bureau as specified in Exhibit 2.

NOW THEREFORE, the Council directs:

- a. Ordinance 188061 is hereby amended to remove Council directive d. and replace it with directive b., below.
- b.The City Budget Office to adjust FY 2017-18 Current Appropriation Level targets for the Portland Housing Bureau by \$3,505,226 to ensure compliance with the Joint Office of Homeless Services Intergovernmental Agreement, Ordinance #187843.
- c. The emergency clause of Ordinance 188061 is hereby corrected to state the appropriate fiscal year of FY 2016-17 for this Fall Supplemental Budget.
- Section 2. The Council declares that an emergency exists in that the Current Appropriation Level target for the Portland Housing Bureau must be correctly adjusted as the bureau is developing its FY 2017-18 budget.
