## Re: Funding for the SW Capitol Highway Improvement Project - Legislative Request

Dear Mayor Wheeler and Commissioners Fish, Fritz, Eudaly, and Saltzman:

On behalf of the Tryon Creek Watershed Council, I want to express our support for the SW Capitol Highway Improvement project. Please include in the city's legislative agenda a request for \$2 million in state funds in order to complete construction of the SW Capitol Highway improvement project, including stormwater upgrades.

This section of SW Portland is in desperate need of stormwater improvements, particularly along the busy arterial through Ashcreek, Multnomah, and other local neighborhoods. Stormwater runoff from SW Capitol Highway between Barbur Boulevard and Multnomah Village significantly contributes to pollutants entering local tributaries, through the mainstem of Tryon Creek to the confluence with the Willamette River.

In addition to improving the safety and accessibility of multi-modal transportation, stormwater improvements will ensure cleaner and cooler water throughout the Tryon Creek watershed, and in support of local wildlife.

We understand that \$3.3 million will be dedicated to this project through the Fixing Our Streets fund, and that Bureau of Environmental Services (BES) and Portland Bureau of Transportation (PBOT) have verbally committed additional project funds. However, the City needs legislative funds to close the gap on the project's estimated \$12 million total.

Again, please include a legislative request for \$2 million to leverage city funds in order to complete the SW Capitol Highway improvement project.

Dear Mayor and City of Portland Commissioners,



### **Re: SW Capitol Highway Project**

Dear Mayor Hales and Commissioners Fish, Fritz, Novick and Saltzman:

The Ashcreek Neighborhood Association borders on SW Capitol Highway in the section between SW Marigold and SW Taylors Ferry road. We have long been concerned that this important arterial – which provides access from southwest Portland to the Barbur Crossroads, Portland Community College and north/south access to I-5 – needs significant enhancements to support the multiple transportation options that serve current needs as well as future population growth on the west side of Portland.

As you well know, many areas of SW Portland are deficient in pedestrian and bicycle transportation facilities needed for safe access to schools, businesses, parks and other services. Over the past several decades, SW Capitol highway has become an increasingly important and high-volume volume arterial supporting multiple transportation modes – auto, truck, bus, bicycle and pedestrian. It has been a high priority of Ashcreek and other neighborhoods in the area to construct needed bicycle and sidewalk improvements between Multnomah Blvd. and Barbur Blvd. – particularly important now as the City encourages alternative transportation modes and this critical link to local and regional services grows in importance. It is an critical link connecting Multnomah Village and West Portland Town Center (Crossroads), which is very likely to be a regional light-rail transit stop in the future.

We vigorously applaud the Bureau of Transportation's commitment of \$3.3 million in gas tax funds to construct this project, which would include bicycle lane, sidewalk and stormwater improvements. We're very happy as well to learn that the Bureau of Environmental Services and PBOT have been supportive of finding additional City funding for the project.
