Reason for the request: I live in Portland. I've had several years of daily police harassment including almost 5 yrs of some Tigard cops shooting me remotely with

microwave weapons, ultrasound weapons, voice to skull command weapons (that's a mind control weapon) Lida machine sleep deprivation etc. They say they shoot my son with these when he's sleeping to give him cancer. They say they voice to skull him all day long. Those at least 8-10 Tigard cops have hundreds and hundreds of other "targets" in Portland. I've reported this to Portland police more than 30 times in this last year and many times before that. They refuse to investigate and stop those cops from shooting us. I have visible injuries including 8 inch swollen abdomen for two years from them shooting me every day there and other places. I testified to Mayor Hales and the Commissioner about this at least 5 times. Hales said, call Project Respond, talk to Tigard Police, talk to Tigard's mayor, call 211. I told him none of those people have authority or will make those criminal Tigard cops stop stalking and shooting us. Tigard is a very corrupt police dept including their police chief. I live in Portland. It's Portland Police's duty to stop and prosecute these crimes. For more than (signed) a year I stand in front of Central Precinct with a 816 SIGN asking them to make those Tigard cops stop shooting us. Most ignore me. Some say hi. I want Ted Wheeler to make Portland Police do their job to protect us. He has the authority to do it.

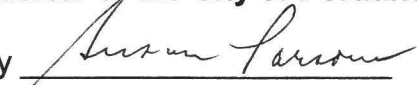
