This email memorializes and confirms a request made by phone on 2017 Jan 13 Friday circa 13:00 U (1:00 PM PT) to reschedule (RS) a confirmed slot for Citizen Communication [AGND PTCC Mtng 2017 Jan 18 Wed 09:30 U](#), Item 39 by myself representing the Birdshill CPO / NA (Clackamas County / City of Lake Oswego) before the Portland City Council (PTCC).

Rationale: Weather and ice melting to clear both neighborhood side streets and residence driveway to enable TriMet LIFT van / Broadway Cab access for safe loading and unloading of my mother a wheelchair bound person aged 102.45 years of age.

Testimony is to occur at PTCC meeting, morning session, on 2017 Feb 08 Wednesday 09:30 U (9:30 AM PT). Similar issues will be addressed to multiple government entities over the course of 2017 weeks 01-09 starting 2017 Jan 02 Tuesday – 2017 Feb 27 Friday – weather and circumstances permitting.

Issue(s) to be addressed include but are not limited to the following:

1. Terwilliger Blvd Sewer Project (TBSP),

Primary Issues: SAFE access to / from Lake Oswego for Birdshill residents for duration of TBSP.

2. Tryon Creek Wastewater Treatment Plant (TCWTP),

Primary Issues: Second instance of selection discrimination in five years by PBES, along with composition and operation of public involvement program and associated exclusion of Birdshill CPO / NA residents from seat(s) on the committee. Note this recognized neighborhood abuts the TCWTP, at 195 Foothills Rd, Lake Oswego OR 97034 on the north side of Tryon Creek.

I may likely be delayed due to un-validated diversion plans and impacts upon my neighborhood by PBES project TBSP (E10413)



and resultant closure of Terwilliger Blvd from OR43 northwest to Castleridge Lane. Further the closure of this critical segment of Terwilliger Blvd has not been field verified for impacts amongst many critical entities including but not limited to: police, fire, ambulance and TriMet LIFT.

Thus due to unpredictable access and response issues associated with dispatch of TriMet LIFT to my mother's residence. Where she has resided since 1952 August (64 years). There is a strong likelihood of delay in pickup and delivery for an elderly handicapped person aged 102.45 years and confined to a wheelchair along with her PCA – Personal Care Assistant (myself).

I may need to appear when delivery is complete to Portland City Hall rather than at the start time of the Portland City Council meeting of 09:30 U (9:30 AM PT)
