Adopt the North/Northeast Community Development Initiative Five-Year Action Plan (Resolution)

WHEREAS, the Interstate Corridor Urban Renewal Area (ICURA) was adopted in 2000 and restated in 2011, dedicating resources to redevelopment and economic development activities;

WHEREAS, the City and Portland Development Commission (PDC) have made significant investments in the ICURA since 2001; but acknowledge that African Americans and other people of color have not fully participated in, or benefitted from economic opportunities in the ICURA;

WHEREAS, the City of Portland and PDC share a commitment to inclusive economic opportunities and acknowledge the importance of investing the remaining \$32 million ICURA TIF resources to benefit people and communities that have experienced displacement or not benefited from those opportunities.

WHEREAS, staff from PDC, Subcommittee of the Neighborhood Economic Development Leadership Group and Interstate community stakeholders have worked collaboratively to draft the N/NE Community Development Initiative Action Plan (Action Plan);

WHEREAS, the Action Plan is consistent with the prior plans, and PDC's 2015-2020 Strategic Plan;

WHEREAS, the Action Plan primary goals are focused on multi-generational wealth creation opportunities, including business and property ownership and redevelopment, new and existing homeownership, non-profit support and catalytic culturally-specific business hub.

NOW, THEREFORE, BE IT RESOLVED, that City Council adopts the North/Northeast Community Development Initiative Five-Year Action Plan attached hereto as Exhibit A; and

BE IT FURTHER RESOLVED, that City Council directs PDC and City staff to work with an Oversight Committee, and community partners to implement the Action Plan;

BE IT FURTHER RESOLVED, that this resolution shall become effective immediately upon its adoption.
