

ORDINANCE No 188235

* Amend Joint Office of Homeless Services Intergovernmental Agreement with Multnomah County to support ongoing implementation of activities to prevent and end homelessness through the partnership with the County and the A Home for Everyone collaborative and increase funds by \$2,558,474 (Ordinance; amend Contract No. 30005335)

The City of Portland ordains:

Section 1. The Council finds:

1. Building on past successful collaborative efforts, in April 2013, the Portland City Council, Multnomah County Board of Commissioners, and Home Forward Board of Commissioners adopted the framework described as A Home for Everyone: A United Community Plan to End Homelessness in Portland and Multnomah County (the “Plan”);
2. In July 2014, to demonstrate further support of the Plan, the Portland City Council, the Multnomah County Board of Commissioners, and Home Forward Board of Commissioners, and Gresham City Council entered into an Intergovernmental Agreement to form the A Home for Everyone Coordinating Board;
3. To build upon prior successes, and to formalize the collaborative model intended through the Plan, the Parties in October 2015 proposed the creation of the Joint Office of Homeless Services (the “Joint Office”) to centralize their respective funding, policy, and planning efforts for homeless services;
4. The County and PHB entered into an Intergovernmental Agreement for the Joint Office of Homeless Services (the “Joint Office IGA”), dated July 1, 2016.
5. The Parties desire to amend the Joint Office IGA to provide a revised budget for City 16/17 funding (“Exhibit H”).

NOW, THEREFORE, the Council directs:

- a. The Commissioner in Charge of PHB is hereby authorized to execute Amendment 1 of the JOHS Intergovernmental Agreement (substantially in accordance with the document attached as “Exhibit A”).


