

## ORDINANCE No. 188237

\* Authorize grant agreement with Hack Oregon, an Oregon non-profit corporation, to build open data web applications to promote engagement, awareness and quality of life with City data, not to exceed \$22,500 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Hack Oregon is an Oregon non-profit corporation that forwards the local digital literacy by providing expertise in software skills training, open source database architecture, interactive product design and data visualization.
2. The City of Portland identifies public value in the storage, open release and visualization of data collected during the continuous implementation of its programs and services.
3. Data visualization platforms provide the public with tools to explore City data according to their own interests, and increase the City's capacity to share information with residents, including traditionally underrepresented populations.
4. An interactive tool enabling residents to gain insights from City data promotes meaningful public engagement built on data made available to Hack Oregon by the City.
5. Hack Oregon's community-powered approach to building web applications offers the City an opportunity to have the public provide input into the design of a tool to promote resident engagement.
6. The City supports and encourages a local technology development community, powered largely by volunteers, that provides Portland with new skills, entrepreneurial capacity, and value-added projects that have influenced local and state government policy.
7. The FY2016-17 Budget includes funding in the External Materials & Services budgets of the City Budget Office, the Portland Housing Bureau, and Portland Fire & Rescue for the above grant. The City Budget Office, the Portland Housing Bureau, and Portland Fire & Rescue now desire to make a grant to Hack Oregon in an amount not to exceed \$22,500.
8. The City's Comprehensive Financial Management Policies, FIN 2.04-Budget, states that grants should be issued after a competitive application process, unless Council waives the policy in the grant ordinance. Because Hack Oregon is the only organization providing this service, a competitive application process was not implemented for this grant.

NOW, THEREFORE, the Council directs:

- a. The City Budget Director is authorized to enter a grant agreement with Hack Oregon in an amount not to exceed \$22,500 and in a form substantially similar to the agreement attached as Exhibit A.
- b. The City Budget Director for this grant is authorized to execute written amendments to the scope of work or terms and conditions of the agreement, provided any amended agreement is approved to form by the City Attorney and the changes do not increase the city's financial risk.
- c. The City Council waives the competitive application process required in FIN 2.04-Budget.
- d. The City Budget Office, Portland Housing Bureau, and the Portland Fire & Rescue Bureaus are hereby authorized to draw and deliver payments chargeable to the Fiscal Year 2016-17 Budget.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities detailed in the agreement; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.

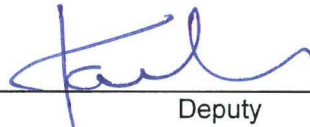
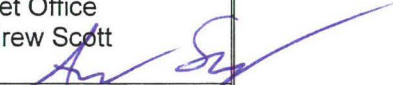

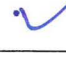
