1. I am concerned about violence and destruction at City Hall:
  - a. Portico blast in 1970s
  - b. Podium fire under Connie McCready
2. Mayor Wheeler is dealing with this new situation realistically:
  - a. Politeness
  - b. Good order
3. But there is a sea-change in public life of City and Country:
  - a. Defense crisis in September 2001
  - b. Financial crisis in October 2008
  - c. Electoral crisis in November 2016
4. This threefold sequence comprises a national catharsis:
  - a. Citizens of influence, wealth, power have become overbearing.
  - b. A substantial minority has been dispossessed of respect, livelihood, family. Perhaps they actually are a majority.
5. Elites are confounded that their perceived inherent superiority is being challenged, as it is based on our two native ideologies:
  - a. Feminism
  - b. Capitalism
6. Both are paranoid delusions. Both typify the extreme self-involvement ineluctably leading to the demise of great nations.
7. We here cannot control the present deconstruction of our nation's long-lived native ideologies that we witness today.
  - a. But with careful thought and prudent actions we can minimize their local effects, of which "homelessness" is a vital one.
  - b. We are playing a new game with new rules. We must think anew and act anew.


